


EU Login - How to create an EU Login account and find your Unique identifier at the Commission (uid)

1. Copy and paste <https://webgate.ec.europa.eu/cas> in your Internet browser bar in order to connect to EU Login to create a new account.
2. Click on the link Create an account. There is no need to fill in the "Use your email address" field.

Passwords cannot include your username and must contain at least 10 characters chosen from at least three of the following four character groups (white space permitted):

- Upper Case: A to Z
- Lower Case: a to z
- Numeric: 0 to 9
- Special Characters: !"#\$%&'()*+,-./:;<=>?@[\\]^_`{|}~


