Transmission of data (AIB)

TOD AIB (8544) –For TA37 the field 'Type of Intervention (Table 3 of Annex VI)' is not mandatory anymore in Table 3 of the TOD.

Certification Body Report (EAGF/EAFRD)

CBR (8302) – Text fields in section 3.4.2.1 Findings has been limited to 500 characters.

Defects Fixed

CAP Strategic Plan (EAGF/EAFRD)

CSP (8432) – Users get an error when displaying Annex V Additional National Financing if there is nothing encoded in the Annex. This has been fixed.

Transmission of data (all)

TOD (8360) – Null checks generate the error SFC_GEN_024 in Tables 5, 6, 7, 9, 10, 11. This has been fixed.

Transmission of data (IJG)

TOD IJG (8432) – The labels for the amount fields in Table 2 overlap. This has been corrected.

TOD IJG (8017) – When editing Tables 2 and 12 some field labels are not wrapping, and the text becomes unreadable. This has been resolved.

TOD IJG (8082) – When creating a new version, Table 1 is not completely copied to the new version. This has been fixed.

TOD IJG (8361) – Table sections should be available in the ToC depending on the funds covered by the related programme. This has been fixed.

TOD IJG (8444) – In Tables 6 and 10 Total target value comes from the programme and should not be overwritten. This has been fixed.

TOD IJG (8482) – In Table 10 when the indicator or target measurement is a percentage, the target total is not displayed correctly and on save values for target and achievement are not correct. This has been fixed.

Payment application (IJG)

PAP IJG (8542) – An error HTTP 500 is thrown when creating a payment application for the next submission period. This has been fixed.

Certification Body Report (EAGF/EAFRD)

CBR (8213) – There are some discrepancies between the user interface and the report preview in sections 5.1.3.1 and 18.1.3.1. This has been resolved.

CBR (8234) - Findings are not shown in section 21.4. This has been fixed.

CBR (8451) – In section 11.1 and in 24.1 the fields 'Amount of expenditure (b) for the population', 'PIR at expenditure level', 'UPI at expenditure level', 'Total Projected Incompliance rate at Expenditure level' and 'Materiality at expenditure level = $2\% \times (b)$ ' should be editable instead of being calculated by the system when stratums are created. This has been corrected.

CBR (8453) – When stratums are added in section 6.1.1 the value 'Most likely Error (MLE) – line 25' should be editable instead of a formula calculation. This has been corrected.

CBR (8536) – Report preview shows YEAR 20YY instead of YEAR 2022 in sections 18.7.2 and 18.8.2. This has been corrected.

Standalone documents

STD (8031) – The country filter is not taken into account when sending notifications to users subscribed via the Event registration. This has been fixed.

STD (8077) – In the search screen User can see documents for which User has access restrictions and the system throws an error when User tries to open the document. Those documents should be excluded from the search result list. This has been corrected.

STD (8352) – Hidden Commission document attachments are downloadable by MS. The MS should not be able to see those documents and has been corrected.

STD (8431) – When searching on column 'Document type' the list of document types shows all document types in SFC whereas it should be restricted to the document types of the current document group. This has been corrected.

General

DOC (8427) – In the object documents section and in the Standalone documents it is not possible to identify if an attachment is hidden or not when in display mode. In display mode the system should show the disabled hide/unhide switch and in edit mode the editable switch will be visible only for the users who can hide/unhide. For the others, the hide/unhide should not be visible and the hidden attachments should never be shown. This has been corrected.

DOC (8523) – The view button is not displayed for the sent documents. This has been fixed.

DOC (8567) – Non-integral unsent documents are not highlighted in red. This has been corrected.

GEN (7470) – The AutoHeight is missing on some tables and has been fixed.

GEN (7592) – Tooltips on the panel below the tab bar don't allow to click on the tabs. This has been resolved.
