AGRI CSP (9106) - Adapt the formula for the Climate tracking.

AGRI CSP (3960) - In the report in chapter 5, display the carry-over questions/answers in the PUA definition table.

GEN SFC (4809) - Breadcrumbs with long texts were causing horizontal scrollbar to show up. This has been modified so that the scrollbar no longer shows.

PRG IJG (8487) – It was impossible to delete a programme after creation. This is fixed.

PRG IJG (7924) - webservice request to appendix 1/2 was giving a nullpointerexception error. This is fixed.

PRG IJG (9075) - Table 11 - Total rows were displaying the region category instead of the description. This is fixed.

Programme AIB

PRG AIB (8912) - Appendix 3 - When a Thematic Facility was accepted, and then deleting a detail the Thematic Facility was not set to open. This is fixed.

CAP Strategic Plan (EAGF/EAFRD)

AGRI CSP (8937) - Planned unit Amount/Output were not correctly displayed in 2.3.13 in case the group is not unique. This is fixed.

AGRI CSP (8899) - Table 7.1 should always be sorted the same way in the report and User Interface. This is fixed.

Prefinancing Request

PFR (7945) – It was not possible to create a new PFR when there were working versions in status 'Revision requested by EC' for the same CCI. This is fixed.

Certification Body Report (EAGF/EAFRD)

AGRI CBR (9134) - Couldn't filter CB Report per Fund. This is fixed.

AGRI CBR (9073) – Create new version - error in 2.3 entity. This is fixed.

AGRI CBR (8976) – CREATE New Version not working in PROD. This is fixed.

AGRI CBR (9020) – EDIT available for TRDI even if other EDIT button is activated for other section + checkboxes. This is fixed.

Declaration of Expenditure (EAGF)

DOE EAGF (8923) - Officials in charge were not copied from previous declaration. This is fixed.

National audit report (ALL)

NAR (9085) - Key requirements – It was not possible to add records for programmes having trailing spaces in its title. This is fixed.

NAR (9062) - Programmes covered - web service was using the CCI title sent by the client. This has been fixed.

Annual control report (IJG ETC EMFAF)

ACR IJG ETC EMFAF (8660) - Report - Annex 3: The table 'Mandatory documents already submitted against previous versions' was added.

ACR IJG ETC EMFAF (8979) - Document section missing in the report. This was fixed.

CCI Request

CCI REQ (6662) - Cancel workflow action should appear under "more actions" menu.

General

GEN DOC (8975) - List of documents - When updating a document to add/remove attachments or modify the hidden field or Ares number, after save the list was not refreshed. This is fixed.

STD DOC (9095) - For standalone documents, the 'Linked CCIs' section should be hidden. This is fixed.

STD DOC (8972) – For Referring documents, on edit, the linked CCIs were not displayed. This is fixed.

GEN (8549) - Export to excel - Data was missing for the columns using indicator renderer component. This is fixed.

GEN (8812) – Issues were found when copy pasting data from a Table to Excel. This is fixed.
