AGRI CSP (8915) - An adaptation of the CAP Plan to add Valid From/Valid To (list of FY/CY list). Valid To will be optional. All budget codes will have a date of effect the next day of the Commission Decision date of adoption (similarly to the current implementation).

TOD IJG ETC (8948) – Table 12 changes.

### **Enabling Conditions**

EC (9334) – Structured menu has been renamed to 'Structured Art.15(4)', and a warning message added on document type ENAC.LC.

### Declaration of Expenditure (EAFRD)

DOE EAFRD (9362) - The Contribution rates per Paying Agencies in 'TOTAL > Expenditure' tables will not be displayed.

DOE EAFRD (9262) - The formula used for the calculation for the Technical Assistance was not correct.

DOE EAFRD (9272) - Technical Assistance rate should be displayed with the full decimal precision we have in the CAP Plan.

# National audit report (IJG ETC EMFAF)

NAR IJG ETC EMFAF (9166) – The NAR for EMFAF has been separated from IJG/ETC.

### Annual control report (IJG ETC EMFAF)

ACR IJG ETC EMFAF (9166) - The ACR for EMFAF has been separated from IJG/ETC.

### **General (Documents)**

GEN DOC (9442) – In the search screen the user was seeing documents he didn't have permissions for. This has been improved.

GEN DOC (9248) – Upload of file types has been restricted for certain objects. An improved error message will be presented to the user.

STD DOC (8787) - Improvements on reply documents.

STD DOC (9126) – Its now possible to define extra CCI filter per document type.

PRG IJG (9228) – A Report error was blocking user from sending to the EC. This is fixed.

PRG IJG (9338) – EC users only – The 'reason' field for 'return for modification' action is required but wasn't marked as such. This is fixed.

### CAP Strategic Plan (EAGF/EAFRD)

AGRI CSP (9372) - AGRI CSP: In the CSP report of France, the section 4.2.1. the system for internal convergence for 'Corse' was not fully displayed. This is fixed.

AGRI CSP (9446) – text was not correctly displayed in excel export for section 'General > Amendment > Detailed information on the specific elements of each modification'. This is fixed.

AGRI CSP (9310) – EC Users only – User could not hide attachment retrieved from ARES during workflow action. This is fixed.

AGRI CSP (6823) - the printout of Chapter 3.1.3 was incomplete. This is fixed.

### Transmission of data (IJG, ETC, AIB)

TOD IJG ETC (8998) – An error was shown when modifying the URL of a TOD detail setting the ID of another TOD type. This is fixed.

TOD IJG (9355) - Import from excel - Error message 'invalid.value' has been fixed.

TOD AIB (9354) - Import from excel - Template for AMIF, ISF, BMVI issues have been fixed.

TOD ETC (9353) - Import from excel - Template for ETC - Column 'ESF secondary theme' expected by the application, but it's not needed.

TOD IJG (9358) - Import from excel - Values validation IJG – Improvement of error messages for record level validations.

TOD IJG (9393) - Import from excel IJG – It was not possible to import records for TA priorities. This is fixed.

TOD IJG (9432) - Import from excel IJG - The validation on category of region was triggered also for JTF and CF. This is fixed.

TOD (9360) - Report - Table 8 was missing the date in column header 4. This is fixed.

DOE EAFRD (9339) - budget code was not correctly displayed in excel export.

DOE EAFRD (9438) - When creating a new version of DOE EAFRD the content of the attachments was not copied.

# Certification Body Report (EAGF/EAFRD)

AGRI CBR (9134) – Couldn't filter per fund. This is fixed.

### **Event Registration**

EVT REG (7106) – It was not possible to register for a CSP event, this is fixed.

# **General (Documents)**

STD DOC (9214) - Sometimes action buttons were not displayed correctly for referring documents. This is fixed.

STD DOC (9215) – The reply button should only be available after the acknowledge action. This is fixed.

STD DOC (9173) - checks on approval date were added to the create and the update actions for Evaluation Plan.

STD DOC (9153) - For ACM Standalone document and the doc type: "Draft minutes" the reply button was also appearing for EC users. This is fixed.

GEN DOC (9352) - Filter cci in the linked CCIs section was working only when adding, not when editing. This is fixed.
