# **New Functionalities**

### **Commission Decision**

COM DEC (9676) – (EC users only) a new feature 'Import from DECIDE' has been added to import Ares documents directly from DECIDE into SFC. For this an extra button 'Import from DECIDE' has been foreseen in the Document list and a new field called 'Procedure reference'. The decision type selector has also been added.

## **Changes**

## CAP Strategic Plan (EAGF/EAFRD)

AGRI CSP (10144) – in section 5.3.8 'State Aid' it is now possible to encode "State Aid case number(s)" when "GBER" or "ABER" has been previously selected.

AGRI CSP (7746) – new Validation rule PRG\_CSP\_015\_040 has been added verifying in chapter General > Amendment/Corrections > Detailed information on the specific elements of each modification, that all text boxes are filled for each Modification' if and only if the version modification is an Amendment.

AGRI CSP (9388) – new Validation rule PRG\_CSP\_582\_0015 has been added to verify that in section 5.3, point 13, the applicable EAFRD contribution rate identified in point 11 is complied with for financial instruments.

AGRI CSP (9389) – new Validation rule PRG\_CSP\_582\_0018 has been added verifying that in section 5.3, point 13, the applicable EAFRD contribution rate identified in point 11 is complied with for Young farmers minimum requirement.

AGRI CSP (9837) – changes have been applied to Annex V. In the second table of the Annex, column "Additional information" is changed into "Total 2023-2027", the text box 'The annual estimated

amount of national financial assistance in the Fruits & Vegetables...' is now printed into the CSP report and validation rule PRG\_CSP\_920 has been modified.

AGRI CSP (9977) – in chapter 5.3.8 it is now possible to encode several State Aid numbers per intervention.

#### Declaration of Expenditure (EAFRD)

DOE EAFRD (9362) – in TOTAL > Expenditure tables the Contribution rates per Paying Agencies are not displayed anymore.

DOE EAFRD (9652) – Bank info and funding Agreement XML files and data are now automatically copied from the previous accepted Quarterly DoE.

#### Forecast of Expenditure (EAFRD)

AGRI PF (9277, 9718) – the system will now send Early/Late warning notifications.

### Certification Body Report (EAGF, EAFRD)

AGRI CBR (9657) – new matrix implemented in GL3.

## **Defects Fixed**

#### **Programme EMFAF**

PRG EMFAF (9934) – In Table 17A the records are not displayed in order. The order should be Fund + Category of region. This has been fixed.

PRG EMFAF (9968) – In Table 13A it is not possible to edit the table when it contains institutions names having > 500 characters. This has been fixed.

#### **Commission Decision**

COM DEC (10110) – (EC users only) the Decision date selected using the date picker is transformed into the previous date on create and send. This has been fixed.

#### Transmission of data

TOD (10070) – a column header is missing in IJG Table 10 and the numbering of the columns in AIB Table 7 is not correct. This has been fixed.

TOD (10094) – the filter on the Specific objective column in Table 3 was not working and has been fixed.

TOD (10098) – in Tables 1 and 3 the filter is not working correctly for the columns that display percentages. This has been resolved.

TOD (10099) – the filter on the Specific objective column in Table 7 was not working and has been fixed.

TOD (10107) – the filter does not work on the columns using indicators reference data and has been fixed in the Tables concerned, i.e. 5, 6, 7, 8 and 9.

TOD (9379) – on creation of the TOD the achievement values should be updated with achievement data from the previous submitted Transmission of data version. This has been fixed.

#### **Enabling conditions**

EC (10179) – in the Search list the link on the Commission Decision did not redirect correctly and has been fixed.

### General

CCI SCH (10131) – CCI Search – the overlay showing the search results is not wide enough and has been fixed.

GEN SFC (5377) – the status icon is not always displayed properly. This is fixed now.

GEN SFC (9695) – the status box lost its style and has been restored.
