PRG EGF (7915) – The calculation of G.3.4 Total EGF contribution towards this application has been changed.

Certification Body Report (EAGF, EAFRD)

CBR (8187) – Incompliance rate UPI and PIR now show in sections 11.2 and 11.4.

CBR (8191) – Number of characters has been increased to 5000 in section 21.1.

Defects Fixed

Partnership agreement

PA (5730) – In Table 1 there's a justification field with a no-limit text box. This has been corrected.

Programme (IJG)

PRG IJG (8113) – An EC user with ESF+ role gets an exception error when generating the report if a TJTP is linked. This has been fixed.

Territorial Just Transition Plan

TJTP (7925) – The link to the Commission decision in the General Info section is not working. This has been fixed.

CAP Strategic Plan (EAGF/EAFRD)

CSP (8114) – An error occurs when generating the comparison report v1.x vs v2.0. This has been fixed.

Transmission of data (IJG)

TOD (8068) – When creating the TOD, the CCI list should be restricted to the CCIs the user has permission to create the TOD. This has been corrected.

TOD (8125) – When creating the TOD, the application is wrongly checking in Table 10 that the programme specific output indicator Measurement Unit size is 20 instead of 383 and generates an error. This has been corrected.

TOD (8209) – An error occurs when creating the TOD if the programme has specific indicators with target value < 0. This has been fixed.

Transmission of data (ETC)

TOD (8067) – A permission error blocks the creation of the TOD and has been fixed.

Transmission of data (AIB)

TOD (8059) – An error 500 is generated when creating a new record for an action type having the calculated flag set. This has been resolved.

TOD (8071) – In Table 3 the table of content is not displayed once there's a record created for one of the action types not having a rate (rate=null). This has been fixed.

TOD (8090) – Baseline values are not copied from the linked Programme version Table 2 when creating the TOD. This has been fixed.

TOD (8186) – A wrong validation is blocking the creation of the TOD. This has been resolved.

Transmission of data (ALL)

TOD (7835) – Discrepancies between the report and the regulation have been corrected.

TOD (8021) – In Table 12 the label for the field Grants should be ‘Grants within a financial instrument operation’. This is corrected.

TOD (8079) – Error messages do not allow to execute the action ‘Request for revision by MS’. This has been fixed.

TOD (8081) – When creating a new version, the content of indicator tables 5, 7, 8, 9 and 11 is not completely copied to the new version. This has been fixed.

TOD (8098) – When exporting the results of the validation rules an error is generated. This has been fixed.

TOD (8217) – In the creation wizard the CCI list content overflows the page when there’re large titles. This has been fixed.

TOD (8218) – The Confirm button is disabled when deleting the object. This has been resolved.

Declaration of Expenditure (EAGF)

DOE EAGF (6609) – There is a problem with the page refresh when opening 2 declaration tabs. This has been resolved.

DOE EAGF (8033) – In the Declaration for Germany 202212.0 the system shows an incorrect number of warnings. This has been fixed.

Certification Body Report (EAGF, EAFRD)

CBR (8112) – The Italian Paying Agency T27 is missing in the database and has been added.

CBR (8197) – Section 12.3 Findings displays an incorrect section. This has been fixed.

General

GEN DOC (7862) – On search page of Documents, when the Title field has a long text, the system does not show the 3dots while truncating the text. This has been corrected.

STD DOC (8029) – For referring documents, the notifications are not sent to users subscribed through Event notifications. This has been fixed.
