

Annual Implementation Report (IGJ, ETC & EMFF) - Types of Documents that can be uploaded and sent by the Member State

The Member State Managing Authority (MSMA) or Member State Responsible Authority (MSRA) is responsible for uploading and sending the annexes to the Operational Programme.

There are two types of documents that can be sent through the **Documents** section of the Implementation Report Programme:

- **Integral Documents:** These documents; 'Citizen's Summary', are sent together with the Programme to the Commission (when the MSMA sends the programme). As a result there is one ARES number and notification to Desk officers. These documents are not visible for the Commission until the Programme is 'Sent'.
