### Changes

#### *Programme*

PRG all (13572) – The maximum size of Appendix 1 fields (Description of the operation type, Verification of the achievement) and Appendix 2 fields (Description of the operation type, Verification of the achievement..., arrangements to ensure the audit...) has been increased.

#### *CAP Strategic Plan (EAGF/EAFRD)*

AGRI CSP (13152, 13176, 13237, 13238 and 13241) –COMPARE on screen in chapter 4 subsections 4.1.5.1 Maximum age limit, 4.1.7.1 Treshold, 4.2.1.1 Entitlements, 4.2.2.2 Subtraction of labour costs and 4.2.4 Contribution to risk management tools.

#### *Ratio of the permanent GRASSLAND (EAGF/EAFRD)*

GSL (13197, 13198 and 13203) – various improvements have been done to the object: CCI added in Version information screen, Value in column E of the table is to be % and the header of column 1 has been updated.

GSL (13200, 13202 and 13280) – various improvements have been done to the validation rules: a new VR 080 has been added, the text for VR GSL\_050 has been updated and the formula for VR 0050 has been changed to %.

## Defects Fixed

### *Programme IJG*

PRG IJG (12957) – In section 2.1 Priority, Fund, Specific Objective the tooltip over Policy Objective was slow to show up and not underlined. It is now set the same way as the tooltip over Specific Objective.

PRG IJG (13249) – In section 2.1.1.1.2 Table 3 Result indicators, when ‘Year to’ is <= ‘Year from’ , the validation error was not always displayed. This has been resolved.

### *Programme ETC*

PRG ETC (13255) – An error 500 was generated when trying to create a new version of a programme. This has been fixed.

PRG ETC (10556) – An issue occurred in the creation wizard when changing from a CCI having choice art17(4)(b) to another without the choice, or when changing the value of that choice from ‘Yes’ to ‘No’ some fields were displayed when not expected. This has been fixed.

PRG ETC (13264) – The strand of the programme was not displayed anymore in the version information section. This has been resolved.

### *Programme IJG, ETC*

PRG IJG ETC (13096) – When editing/deleting a Priority – Specific Objective combination the related information was not correctly updated. This has been fixed.

### *CAP Strategic Plan (EAGF/EAFRD)*

AGRI CSP (11915) – TOC items were not sorted correctly under section 3.10 (GAEC) on the screen and in the report. This has been fixed.

### *Annual Performance Report (EAGF/EAFRD)*

AGRI APR (13136) – Sector Annex VI information from 2.1 and other sections was not standardized for sectorOtherName. The same format is now user across the report.

AGRI APR (13266) – Filtering on the different columns of the Search list was not working. This is now fixed.

AGRI APR (13641) – When the previous version has been Returned for technical correction the Prepare for Send button was not displayed. This has been resolved.

### *European Innovation Partnership (EAFRD)*

AGRI EIP (13301) – An error message was blocking the submission of the EIP project to the Commission for multi-node countries and has been resolved.

AGRI EIP (13586) – An error message was generated by the system when saving the ‘editor/project coordinator’ section. This has been fixed.

### ***Ratio of the permanent GRASSLAND (EAGF/EAFRD)***

GSL (13284) – Search by CCI was not working and has been fixed.

GSL (13302) – An error message was blocking the submission of the GSL project to the Commission for multi-node countries and has been resolved.

### ***Enabling Conditions Structured Art. 15(4)***

EC (10978) – Some columns were missing when exporting the Search list. This has been fixed and the order of the columns in the export file has also been aligned with the order of the columns on screen.

### ***Payment Application***

PAP All (13684) - The fields ‘Fund’ and ‘Accounting year’ were not displayed anymore in the version information section. This has been resolved.

### ***Payment Application AIB***

PAP AIB (13652) – When choosing the linked programme version, versions in status ‘Adopted by MS’ were ignored. This has been fixed.

### ***Declaration of Expenditure (EAFRD)***

AGRI DOE (12938) – An error message was preventing Wallonia to create a Declaration. This has been fixed.

### ***Payment Forecast***

PF All (12867) – The system allowed reopening a Payment forecast having more recent working versions. This has been corrected.

### ***Accounts***

ACC All (13267) – On signature of the Accounts, Management declaration and Audit Opinion the system was saving the signer’s First name and Last name in the database instead of the ECASuid which, in some cases, generated an error message blocking the signing. This has been fixed and the system now correctly saves the ECASuid.

ACC All (13188) – The column width has been corrected in the report for Appendix 4.

### ***Certification Body Report & Audit Opinion (EAGF/EAFRD)***

AGRI CBRN (13293) – The currency has been changed for HR from HRK into EUR.

### ***Annual Accounts and MD(s) (EAGF/EAFRD)***

AGRI ACA (13069) – An exception error was generated when uploading a XML file including namespaces. This has been fixed.

AGRI ACA (11942) – Filtering on the different columns of the Search list was not working. This is now fixed.

AGRI ACA (13169) – When the MS returned the Accounts, the lower node signed the Accounts, but the status was not changed from 'Request revision by MS' to 'Open' and therefore the owner node was not able to Validate and Send again (buttons were missing). This has been resolved.

AGRI ACA (13178) – An error was generated when exporting the list of Annual Account versions and has been resolved.
