Operational Programme SFCF, CP ETC and IPA CBC:

- The programme authorities have to be copied from the last adopted designation of authorities (if newer than the current programme version)
- The more recent between the previous programme version and the DOA will be taken and copied into the new programme version

Operational Programme EMFF:

- New validation rule added: 2.41 validate that an indicative EMFF contribution has been introduced in section 9.2 (warning)

Defects fixed:

Standalone Documents:

- Ex Ante Conditionality Documents that were linked to a PAA can be created but when performing the search again it wasn't visible in the results.
- Commission documents were not shown when using the country filter.

Application (EGF):

- Validation 2.2 corrected: Both Legal Entity and Bank Account should be present in order for validation to succeed.
- EGF - Section G.1 Measures - An error was appearing when trying to add a measure in table G1.1 having 0 as the value for the NEETs fields.

RDP Programmes:

- Problems sending RDP programmes fixed.
- RDP: increase Section '5.2.Mxx.c.Oyy.8. (Applicable) amounts and support rates' to 9000 char (approx 2,5 pages) only for NF.
- RDP: problem editing field 'Action to be taken' in section 6.3 fixed.

IPA CBC:

- IPA CBC: validation rule 2.79 should run only against version 1.0 and not against all 1.x

AMIF/ISF National Programmes:

- Defect on 'Clear' functionality when 'Fund' filter is active corrected (fields now cleared).

Simplified Cost Option:

- Fixed issue with last modified date of Version 1 being updated with modification date of version 1+.
