Operational Programme (IGJ)

OP IGJ (13781) – There is a new validation rule 2.129: *Validate in table 18a, that the column ‘100% co-financing rate for accounting year 2021-2022’ for a Priority Axis, Fund, Category of region, was not compared to last adopted version (error)*

Operational Programme (FEAD)

OP FEAD (13513) – There is now an extra editable column in the Annual Financial Plan, related to CARE with a checkbox through which the MS can request 100% for the 2021-2022 accounting period.

OP FEAD (13783) – There is a new validation rule 2.19: *Validate in the Financing Plan by Year, that the column ‘100% co-financing rate for accounting year 2021-2022’ was not compared to last adopted version (error)*

Cooperation programme (ETC)

CP ETC (13782) – There is a new validation rule 2.107: *Validate in table 16, that the column ‘100% co-financing rate for accounting year 2021-2022’ for a Priority Axis, Fund was not changed compared to last adopted version (error)*

Cooperation programme (ENI-CB)

CP ENI CB (13785, 13786, 13787, 13788) – There is now in the Financing Plan per Priority, a new column for the Member State to indicate that a Priority will benefit from Article 3 of Regulation (EU) 2022/2192, providing no co-financing during accounting periods 2021, 2022 and 2023. There is also a new validation rule

2.20 for that purpose: *Validate in the Financing Plan when a tick-box “No co-financing for accounting years starting in 2021, 2022 and 2023” is ticked, that the Programme works with Ukraine and Moldova (2014TC16M5CB009, 2014TC16M5CB010, 2014TC16M5CB011, 2014TC16M5CB012, 2014TC16M6CB001)*

CP ENI CB (13789) – The Financial Table layout is now changed in all Print versions.

Rural Development Programme (EAFRD)

RDP EAFRD (13770) – The Validation Rule 150 was deactivated and replaced by rule 151: *Validate that the totals and performance reserve of the Annual Financing Plan table of section 10.1 did not change compared to the previous adopted RDP*

Implementation report (FEAD)

IR FEAD (13791) – The reporting year list will also contain the value '9999' which corresponds to the Final Implementation report.

Accounts (EAFRD, EAGF)

ACC EAFRD EAGF (13779) – For the Annual Account version >=2022, in section 'AUDIT OPINION AND REPORTS - ART 30(1)(B) NO 908/2014 > Report and Annex documents', it is no longer possible to upload documents. Instead, there is a message saying that: 'Certification Body report and related annexes should be provided through SFC2021 and not SFC2014 anymore'. The PDF report and the validation rule that verifies that the mandatory documents have been uploaded were adapted accordingly: *ACA_050 validate that all mandatory documents have been uploaded or already sent in a previous Clearance of Accounts version. (For Annual Accounts >= 2018 ignore Management Declaration and Audit opinion document types; or Annual Accounts >= 2022 also ignore and CBR/Annexes document types) (warning)*

Defects fixed:

Operational Programme (IGJ)

OP IGJ (13746) – The validation rule VR2.110 was changed since the text wasn't telling from where the error was coming from. Now it says: *In table 7 for Core Priority Axes, the intervention field with dimension code "{0}" of priority axis "{1}", Fund "{2}" and category of region "{3}" needs to correspond to one of the investment priorities of that priority axis.*

Rural Development Programme (EAFRD)

RDP AGRI (13798) – The Contribution rate for EURI was set to 0 when a new measure was added in the programme. This is fixed.

Accounts (EAFRD, EAGF)

ACC EAFRD EAGF (13779) – The message in the Management Declaration section was adapted: *For Member States applying Articles 1, 2 and 3 of Regulation (EU) No 2021/725 and/or the provisions under Chapters I, II and III of Regulation (EU) No 2022/1216*

Annual control report (IGJ,ETC)

ACR IGJ ETC (13795) – The Validation Rule 2.8 wasn't working correctly since it was retrieving all working versions of an ID, instead of only the last one. This is fixed.
