Major project submission (Art. 102(2))

MPS (13796) – There is a new ‘Cancel’ action for the EC user for programmes that are currently in status ‘Adopted by EC’ and ‘Acknowledged by EC’ resulting in status ‘Cancelled’. With this action, the European Commission User must add the document type ‘EC acknowledgement of cancellation’. The Member State is allowed to create a new version on status ‘Cancelled’. The Member State is no longer allowed to create or send an ‘Other MS document’ when Major project was once ‘Adopted by EC’. There is a new validation rule 2.70 checking that section C3 was filled in: 2.70 - *Validate in C.3 that a ‘Method of calculation’ is selected and*

- *when it is ‘Calculation of the discounted net revenue’ (1), that a ‘Total eligible cost before ...’ is provided,*
- *when it is ‘Flat rate method’ (2), that a ‘Total eligible cost before ...’ is provided,*
- *when it is ‘Decreased co-financing rate method’ (3), that a ‘Total eligible cost before ...’ and ‘Total eligible cost after ...’ is provided,*
- *when it is ‘Project subject to state aid’ (4), that a ‘Total eligible cost before ...’ and ‘Total eligible cost after ...’ is provided (error)*

Major project notification (Art.102(1) and 103)

MPN (13797) – There is a new ‘Cancel’ action for the EC user for programmes that are currently in status ‘Tacitly approved by EC’, on ‘Acknowledged by EC’ and on ‘Approved by EC’, resulting in status ‘Cancelled’. With this action, the European Commission User must add the document type ‘EC acknowledgement of cancellation’. The Member State is allowed to create a new version on status ‘Cancelled’. The Member State is no longer allowed to create or send an ‘Other MS document’ when Major project was once ‘Approved by EC’. There is a new validation rule 2.29 checking that section C3 was filled in: 2.29 - *Validate in C.3 that a ‘Method of calculation’ is selected and*

- *when it is ‘Calculation of the discounted net revenue’ (1), that a ‘Total eligible cost before ...’ is provided,*
- *when it is ‘Flat rate method’ (2), that a ‘Total eligible cost before ...’ is provided,*
- *when it is ‘Decreased co-financing rate method’ (3), that a ‘Total eligible cost before ...’ and ‘Total eligible cost after ...’ is provided,*
- *when it is ‘Project subject to state aid’ (4), that a ‘Total eligible cost before ...’ and ‘Total eligible cost after ...’ is provided (error)*

Financial data (IGJ,ETC)

PF IGJ ETC (13782) – The validation rules 2.26 and new VR 2.34 were changed for FAST CARE:

- 2.26 validate in Table 2 for IGJ on non-REACT-EU, non-CARE, non-REACT-EU CARE Priorities covering ESF that only "Intervention Field" codes between 102 and 123 are used (error) => "In Table 2 for ESF, the intervention field code needs to be between 102 and 123 for priority axis: {0}, Fund: {1}, region category: {2}, intervention field: {3}, form of finance: {4}, territorial type: {5}, territorial delivery mechanism: {6}, ESF secondary theme: {7}, economic dimension: {8}, location: {9}.
- 2.34 validate in table 2 for IGJ on CARE Priority Axes, that the "Intervention Field" code (102 to 120 only) is the equivalent of an IP covered by the Priority Axes (error) => "In Table 2, the intervention field needs to correspond to an investment priority covered by the priority axis and Fund in the programme. Priority axis: {0}, Fund: {1}, region category: {2}, intervention field: {3}, form of finance: {4}, territorial type: {5}, territorial delivery mechanism: {6}, thematic objective: {7}, ESF secondary theme: {8}, economic dimension: {9}, location: {10}.
