### New Functionalities

#### Changes

##### *Partnership Agreement*

PA (3301) – The security check when a Commission user makes a search for Partnership Agreement has been optimized.

PA (3336) – VR PA\_077 – The validation rule should only be triggered when the ‘transfer of ERDF and ESF+ resources as complementary support to JTF’ was ticked in Section 4 and has been changed as such: “Validate when the transfer of ERDF and ESF+ resources as complementary support to the JTF was ticked in section 4 that in table 6B that the “Article 3 JTF Regulation allocation prior to transfers” is equal to the initial JTF allocation from MFF resources (as communicated to the MS).”

## ***Programme IJG***

PRG IJG (3296) – VR PRG\_IJG\_008 – the validation rule has been modified and now only triggers for ESF+ priorities defined in Table 1.

## ***Programme EMFAF***

PRG EMFAF (3294) – VR PRG\_EMFAF\_079 – new validation rule added: “Validate when appendix 4 exists that the sum of structural support + compensation + other investments of all outermost regions is not less than €102,000,000 for PT, €82,000,000 for ES and €131,000,000 for FR. (Error)”

PRG EMFAF (2638) – VR PRG\_EMFAF\_083 – the validation rule has been modified.

PRG EMFAF (3082) – VR PRG\_EMFAF\_134 – new validation rule added: “Validate in table 11A, for each priority, specific objective, if the Member State has chosen TA according to Art. 36(5) in their PA, that the “Union contribution for TA pursuant to Article 36(5)” divided by the “Union contribution without TA pursuant to Article 36(5)”, is 6% (between 5,95% and max. 6%). (Error)”

## ***Programme AIB***

PRG AIB (3234) – Appendix 3 Thematic Facility – ‘Description of the action’ field has been set as mandatory.

## ***CAP Strategic Plan (EAGF/EAFRD)***

CSP (865) – Chapter 6.1 Overview table has been included in the print report.

CSP (2901) – Annex 1 Ex-ante evaluation is added as a structured section in the CSP.

CSP (3300) – In Chapter 5 WTO the link to the payment entitlement is no longer displayed in case of eco-scheme 31(7)(b).

CSP (3319) – In the ‘Planned Unit Amounts - Financial Table with outputs’ table, the carry-over and minimum annex XII rows are now split in 2 rows: public and union contribution.

CSP (3285) – In the ‘Planned Unit Amounts - Financial Table with outputs’ table a row has been added for Maximum Amount (only applicable for wine and apiculture).

## ***Territorial Just Transition Plan***

TJTP (3108) – In workflow ‘Mark as completed’, the event definition has been updated to add CCI, version and work version of the programmes. It should now generate one event for each related programme version to the completed TJTP (up to now it was only one event per TJTP version). Only the last versions of the programme are taken into account.

## ***Application EGF***

PRG EGF (3265) – the Date of the notification to the Commission of the decision of the BA has been added on the Version Information page.

PRG EGF (3266) – Parliament & Council Decision Number and Date are now optional during Link to Commission Decision.

PRG EGF (3293) – Uploading a Withdrawal justification letter is now mandatory to withdraw.

PRG EGF (3322) – VR PRG\_EGF\_002 has been changed and will now check that documents are sent.

## ***General***

REG (3249) – The possibility has been foreseen to skip the filing plan when needed in multi-DG programme.

REG (3327) – The attributions made in Ares are now added to the DOCREG event.

GEN (3348) – Old MS Office file formats (.doc and .xls) can no longer be uploaded in SFC2021.

GEN (3316) – The layout in the Version information screen has been improved.

## ***Defects Fixed***

### ***Partnership Agreement***

PA (3069) – History section triggers an error HTTP 500. This has been fixed.

PA (3256) – VR PA\_070. The validation rule should only be triggered when the transfer between categories of regions was ticked in Section 4 and only for the transfers defined in Table 3A/3B. Before, the rule was also validating the initial allocations for other categories of region (which are not in Table 3A/3B).

### ***Programme IJG***

PRG IJG (3238) – Actions buttons were disappearing after editing the funds. This has now been fixed.

PRG IJG (3333) – Table 12 Enabling conditions was not showing all criteria. This has been fixed.

PRG IJG (3204) – Some backend validations for mandatory fields were missing in sections 2.1.1.1.2 Table 2 (common and reserved indicators).

PRG IJG (3206) – Sometimes the Save button became unresponsive when editing Appendix 2 Summary. This is now fixed.

PRG IJG (3344) – Percentages in the report under Annex 1 Summary were not shown correctly. This has been fixed.

PRG IJG (3332) – In the Version information section the Amendment fields are visible or hidden when not expected. This has now been fixed.

### ***Programme ETC***

PRG ETC (3314) – Table 2 and Table3 have been corrected in the report and now show per SO instead of repeating the data.

### ***Programme AIB***

PRG AIB (3236) – it was not possible to enter negative amounts during Accept Decision. This has now been fixed.

PRG AIB (3205) – Table 8 allowed to save without filling the mandatory fields. This is now corrected.

PRG AIB (3274) – When editing a thematic facility for ISF or BMVI the list of interventions was empty. This has been fixed.

PRG AIB (3354) – In Table 6 the calculation of TA36(5) was not working correctly and has been fixed: TA36(5) is  $\text{ROUNDDOWN}((\text{SUM}(\text{Sos})+\text{TA37}) * 6\%)$ .

PRG AIB (3258) – a warning error was shown when pasting values into a cell during Accept decision action. This is now fixed.

### ***CAP Strategic Plan (EAGF/EAFRD)***

CSP (3305) – In Annex XIII (now Annex VI) PUA table, the name of the total column should be 'Total 2023-2028'.

### ***Territorial Just Transition Plan***

TJTP (3248) – An exception error was generated when Section 4 Justification is empty.

### ***Application EGF***

PRG EGF (3021) – Typos and missing words have been corrected in the Report sections D, G, I, J and K.

### ***Programme ALL***

PRG ALL (3275) – When creating a new version of a programme, the version number in the Version information section was not updated. This has been fixed.

## *General*

GEN (2413) – PA PRG TJTP CCIREQ – In PA and PRG there were a number of non-rich text fields where the default character counter was counting spaces. This has been corrected.

GEN (3202) – Numeric fields – the Save button was enabled when there're required fields empty. This has been corrected.

GEN (3290) – Search page pagination was not working correctly when you sort on Status or by Previous Node or by Current Node showing the same records twice while other records disappeared. This is now corrected.

GEN (3321) – Security – as from now an EC user needs permission from leading DG in order to do an update action.

GEN (3334) – A regression was found when the programme tries to process the DOCREG events. This is now fixed.

GEN (3246) – Negative amounts should be allowed on numeric fields when filling from keyboard. Until now it was only working when copy-pasting.

GEN (3276) – Integral documents were added into the snapshot document. This has been corrected.

GEN (3281) – In some case in the result of the validation the parameters were not replaced in the right order. This is now fixed.

GEN (3219) – Action buttons were not updated after editing a table. This has been fixed.

GEN (3324) – The application menu was not collapsing when clicking in 1 menu. This is now fixed.
