PA (1788) - Section 11 enabling conditions - On edit mode, for Horizontal conditions, all MS valid funds should now be automatically selected.

Programme IJG

PRG IJG (3718)- Table 13A only shows content when there's more than 1 record.

Territorial just transition plan (TJTP)

TJTP (3880) – the application now allows EC users to consult unsent documents of type TJTP Supplementary Information.

Programme EMFAF

PRG EMFAF (3718) - Table 13A only shows content when there's more than 1 record.

CAP Strategic Plan (EAFRD/EAGF)

AGRI CSP (3901) – Missing links between possible sectoral objectives and specific objectives have been added.

AGRI CSP (3860) – The possibility to add cross-cutting objective in sectoral intervention has been added.

AGRI CSP (3902) – In the Report the Planned Unit Amount tables of chapter 5 has been improved:

-the description of the output is removed and unit is added

-the empty line after the last contribution rate is removed

AGRI CSP (3714) – sectoral objective 46(k) is now linked to all types of interventions.

AGRI CSP (3703) – as the character counter now takes into account blank spaces, the maximum number of characters for chapter 2 'Strategic Statement' is now increased from 7000 to 9000 characters.

AGRI CSP (3719) – in section 4.7.4 Contribution rate(s) applicable to Rural Development interventions, the system now allows the MS to define one contribution rate for each type of intervention defined within article 91(3)(b), at national and/or regional level.

AGRI CSP (2900) – Annex IV for cotton has been integrated in the CSP as a structured section instead of a document and allows the MS to create an intervention for cotton directly in the application.

AGRI CSP (3869, 3870, 3871, 3798, 3892, 3894, 3895, 3898, 3906, 3884, 3890, 3750, 3733, 3946) – Multiple improvements for Excel export.

AGRI CSP (3952) – Spell-check disabled in the report.

AGRI CSP (2543) - In chapter 5 'EU WTO schedule on oilseed' for sector added.

AGRI CSP (3707) - in chapter 5.2.2 the article (legal base) was added into brackets after the sectoral TOI code.

AGRI CSP (4012) - In the report 6.2 the type of support for each RD PUA is now displayed.

AGRI CSP (4016) - in the report 6.2 the tables are now sorted by type of intervention (legal base) and then by intervention MS code.

AGRI CSP (4009) - in the report the type of eco-scheme is added in the table of intervention and in intervention fiche.

AGRI CSP (3922) - In the report, the intervention cotton should be generated under Annex IV with the relevant textual sections only.

AGRI CSP (3730) – Print for chapter 5 subsection "Rate of support" created.

Defects Fixed

Partnership Agreement

PA (1792) - When editing a validated PA, the status should now correctly change to open.

PA (1767) - section 5 - The choice on article selected/to be selected should be visible at first sight.

PA (3771) - Transfers tables 5A and 6A - When adding a record without any amount, a 500 error was displayed and from that moment a 500 was always displayed when trying to view those sections. This is fixed.

PA (1778) - section 6.1 - The last option should not be available when the MS doesn't have the CF fund.

PA (1762) - section 7 table 8 - First column pinned.

PA (3741) - Table 8 Financial allocations - After saving, TA values and Total values were not displayed and orange messages were shown. This is fixed.

PA (1763) - section 8 tables 9A/9B - CCI title added as a tooltip.

PA (1740) - section 8 tables 9A/9B - import buttons were missing.

PA (3422) - List of programmes Tables 9A/9B - The import button showing the number of allocated CCI not included in the list was showing an incorrect number. This is fixed.

PA (1757) - Report - Not possible to generate (500 error) has been fixed.

PA (3815) - Report - Table 11 last column text was extending the page width. This is fixed.

PA (1741) - section 11 enabling conditions - On add/edit, the list of selected specific objectives was cleared-up on unselecting a fund. This is fixed.

PA (1784) - section 12 – Footnote removed.

PA (1779) - section 12 - The last row should not be available when the MS doesn't have the CF fund.

PA (1795) - Search page - An error GEN_013 was displayed when trying to filter by date. This is fixed.

PA (1738) - Search page - For MS users, filters 'current/previous' nodes were not restricted. This is fixed.

PA (1742) - workflow. create new version - when PA version is withdrawn and no previous adopted version exist, the message was not correct. This is fixed.

PA (1743) - workflow. withdraw – It was not possible to withdraw a programme which was not in status Sent to EC. This is fixed.

Programme IJG

PRG IJG (3715) –Table Result indicators - The year fields were treated differently depending on the type of programme. This is fixed.

PRG IJG(3722) - Display N/A for not applicable fields in the validation rules.

PRG IJG (3709) - Error was occurring when trying to delete a priority in use in table 18A. This is fixed.

PRG IJG(1165) - Firefox wasn't displaying the tables like Chrome was. This is fixed.

PRG IJG(3701) - Table 13A - Percentage fields should accept values between 0 and 100.

PRG IJG (3438) - Version info - The commission decision number and date were not displayed when the programme is Adopted by MS. This is fixed.

PRG IJG (3930) - Unable to send IJG programme when TJTP was referenced from a node not in the lower consultation hierarchy. This is fixed.

Territorial just transition plan (TJTP)

TJTP (3858) - selecting another rich-text Table of Content item was not refreshing the content. This is fixed.

Programme ETC

PRG ETC (3796) - Table 3 Result indicators - A 500 error is displayed when programme specific indicator had the field

Programme EMFAF

PRG EMFAF (3790) - Table 13 - The programme authority list should be filtered depending on PA technical assistance article chosen.

PRG EMFAF (3615) - Table 3 Result indicators - The field 'Last reference year' was marked as mandatory and it shouldn't be. This is fixed.

PRG EMFAF (3704) - User expected to see "Non-substantial transfer" ,"Clerical or editorial corrections", " Approved by monitoring committee" but none of these checkboxes appears on UI when first programme version sent to EC. This is fixed.

PRG EMFAF (3792) – It wasn't possible to add more than 1 Authority. This is fixed.

PRG EMFAF (3759) - Unexpected error was blocking editing in Table 11A. This is fixed.

'from' reference year empty and the field 'to' not empty . This is fixed.

CAP Strategic Plan (EAFRD/EAGF)

AGRI CSP (3705) – An error occurred while deleting an intervention with R11. This is fixed.

AGRI CSP (3839) - in chapter 5.2.2 of the report, the article (legal base) has been added in brackets after the sectoral TOI code.

AGRI CSP (3936) - In chapter 5.3.12, the contribution rates are now sorted alphabetically by articles and then by NUTS code.

AGRI CSP (3561) - in section '5.3.7 Form and rate of support/premia/calculation methods' an 'additional explanation' rich text field has been added.

AGRI CSP (3947) - Section 4.1.5.4 was missing in the report. This is now fixed.

AGRI CSP (3954) - text field 'Define eligible beneficiaries and specific eligibility ...' of section 5.1.5 was missing in the report. This is now fixed.

AGRI CSP (3805) - in some sections it was not possible to fill decimals for amounts, percentages, hectares. This is fixed.

AGRI CSP (3948) - In the report chapter 5, units (or custom units) were not correctly displayed in the Planned Unit Amount tables, same for custom units in 6.2. This is fixed.

AGRI CSP (3843) - In the report, some texts (encoded in rich text boxes) were displayed in grey instead of black. This is fixed.

AGRI CSP (3994) - Missing description field content added in section 7.1 of the report.

AGRI CSP (3365) – Not all sections were cloned in a new version. This is fixed.

AGRI CSP (3839) - In chapter 5.2.2 of the report, the article (legal base) has been added in brackets after the sectoral TOI code.

AGRI CSP (3920) – In the report the section 4.3.2 and 4.3.3 were empty. These are fixed.

AGRI CSP (3986) - in the report, the data for annex VI were missing in the table 6.2. This is fixed.

AGRI CSP (3935) - In the system and report, in chapter 2.3.1 the SO and XCO were not sorted alphabetically by code. This is fixed.

CCI Request

CCI REQ (1785) - On allocate the field 'English title' was pre-filled with the requested title, instead of the requested English title. This is fixed.

CCI Request (3634) – An error was occurring when the user was requesting a CCI without a document attached. This is fixed.

CCI Request (3372) – Uploading an invalid format document shows two messages. This is now fixed.

General

GEN DOC (3955) – Documents were not closing by clicking "ok" in view mode. This is fixed

GEN (3245) - Pasting multiple cells in a table was not working. This is now fixed.

GEN (3711) - Richtext Characters < and > were translated to html entities. This is fixed.

GEN (3436) - Search list - When exporting the search results, the columns containing numbers weren't maintaining their formatting. This is fixed.

GEN (1745) - After executing a workflow action the workflow button bar was not refreshed. This is fixed.

GEN (3289) - Help icon "i" should be displayed on each TOC item.

GEN (1760) - The height of the tables should depend on the content.

GEN (3804) - Pressing ESC button on keyboard was making the app unresponsive. This is fixed.

GEN (1679) - Validation on text fields and text area types should not take into account empty trailing spaces.
