PA (3207) – Validations to check mandatory fields was missing. This is fixed.

AGRI CSP (4075) – An error occurred when generating some reports. This is fixed.

AGRI CSP (3933) - All rich text should now be displayed with a border and a white background.

AGRI CSP (4084) - Images were not resized correctly in the report. This is fixed.
