Programme (IJG, ETC)

PRG IJG ETC (4133) – In Appendixes 1.A and 2.A Summary table SCO non applicable column added.

Programme (ETC)

PRG ETC (4296) - Allow to select authority type “Body other than the managing authority entrusted with the accounting function” in Table 9, although it is not foreseen in the official template.

CAP Strategic Plan (EAGF/EAFRD)

AGRI CSP (3309) - in the Interface and report the Annex I recommendations table are sorted alphabetically by title/reference.

AGRI CSP (3240) - Annex VI 'on transitional national aid' is integrated in the content of the CSP as a structured section.

AGRI CSP (3981) - Translation messages are added when generating the report.

AGRI CSP (4238) – Member States should always have the possibility to edit Authorities table in latest CSP version.

AGRI CSP (4000) - include the Public expenditure in the financial tables for apiculture and include a dedicated box in section 3.5.2 where MS can include the “description of an established reliable method for determining the number of beehives ready for wintering in the territory of the Member States between 1 September and 31 December” as per Art.38 of the Draft Delegated Act.

AGRI CSP (4138) - When a user creates a new version of a CSP, he should be automatically redirected to this new version.

AGRI CSP (4320) - Missing sections added in the pdf report.

AGRI CSP (3262) - Print created for chapter: "6.2 detailed table with outputs".

Defects Fixed

Partnership Agreement

PA (4294) - the tab page was not visible when viewing the PA from a direct link. This is fixed.

Programme (IJG)

PRG IJG (4350) -Creating a new version was failing. This is fixed.

PRG IJG (4343) - Edit - Table 11 - When the programme uses TA in accordance to article 36(5), the backend validation on flexibility amounts for JTF article4 was missing. This is fixed.

PRG IJG (4313) - Edit - Table 11 - When the programme uses TA in accordance to article 36(5), the fields for flexibility amounts should be disabled for JTF Article 4. This is fixed.

PRG IJG (4241) - In Table 3 it was not possible to re-select similar ID Common Result Indicators. This is fixed.

Programme (ETC)

PRG ETC (4291) - metadata for Appendix 1B and 2B were wrong, the list of the Specific Objectives (SO) should be based on the priority SOs and not the Table 1 SOs. This is fixed.

PRG ETC (4236) - when deleting a Priority it was not being deleted in S2 nor in the Appendix. This is fixed.

Territorial Just Transition Plan

TJTP (4298) - Edit - Section 4 Justification - There was a 405 error on accessing the section. Then when trying to save, it wasn't saving. This is fixed.

Programme (EMFAF)

PRG EMFAF (4324) – When editing Table 9 Type of intervention the list of intervention codes was growing each time the user saved a row. This is fixed.

PRG EMFAF (4365) – In Table 12 of the Report the fulfilled flags of the criteria were not shown correctly. This is fixed.

Programme (AIB)

PRG AIB (4316) - In Programmes AIB the thematic facility wasn't showing the Type of Intervention for the ISF programmes.

CAP Strategic Plan (EAGF/EAFRD)

AGRI CSP (4288) - Submission date was incorrect. This is fixed.

AGRI CSP (4300) – There was an issue with retrieving the list of Budget Codes. This is fixed.

AGRI CSP (3921) - Some Germanic letters like ä, ö, ü and ß were not correctly displayed in the report. This is fixed.

AGRI CSP (3734) - When deleting R11 from all SO/XCO in chapter 2, then R11 should now also be deleted from all the interventions/PUA.

General

GEN SFC (4326) - Percentage fields in Appendix 1A were accepting large values. This is fixed.

GEN SFC (3398) – In Rich text pages the toolbar buttons for bullets and numbers lists did not work and were generating an error when clicked. This is fixed.

GEN SFC (3740) – In Rich text, Text areas and Text fields the required field validation was failing when the field value contained trailing spaces. This is now fixed.

GEN SFC (4233) - Some cells of the table 11 were editable even if the user was not in edit mode. This is fixed.

GEN SFC (2167) - Print button and object tab were disappearing after browser refresh. This is fixed.

GEN SFC (4366) - Validation process was taking too much time to complete. This is fixed.
