PA (5052) - Section 7 table 8 – When Table 7 loaded in view mode, some of the amounts were not displayed. This is fixed.

PA (5077) – Section è table 8 On save an error appeared. This is fixed.

Programme (IJG)

PRG IJG (4969) - Section 3 Table10 - When the user copy pasted amounts having decimal separators there was an error upon save. This is fixed.

PRG IJG (4468) - In TJTP section, the list to choose a TJTP would say 'loading...' even if the list was already charged or no TJTP was available. This is fixed.

PRG IJG (5056) - Table 12 enabling conditions - On edit, the edit action is not registered in the history and the status of the programme is not set back to Open

PRG ETC (5073) - General Version Info – It was not possible to replace the CCI with a multifund CCI for the same object subtype. This is fixed.

PRG AIB (5029) - In Table 6 the "Save" button should not be enabled by default. This is fixed.

AGRI CSP (4866) – The title was missing in the breadcrumb for chapter 3.10.1. This is fixed.

AGRI CSP (5025) - Output indicator 'Other unit' encoded by MS were not displayed in table 2.3.2. This is fixed.

AGRI CSP (3982) - Error when generating the report is fixed.

AGRI CSP (4945) - Error when creating a planned unit amount in certain conditions is fixed.

AGRI CSP (4761) - Transfers from hops in financial table 6.1 is fixed.
