AGRI CSP – Improve messages for some Validation Rules and new rules created.

AGRI CSP (5736, 5734) - Implemented Draft Annex Decision report and menu entry 'Draft Annex Decision' added in the upper right corner menu for CSP.

AGRI CSP (6006) – Improvement to slowness of the system when encoding the Annex I, chapter 2 Recommendations of the ex-ante and SEA.

AGRI CSP (5993) – The possibility of measurement unit 'projects' added for output indicator O.31.

AGRI CSP (6042) - The document type CSP.EAA is set as mandatory (Annex I: Ex-ante evaluation and Strategic Environmental Assessment).

PRG EMFAF (5865) - Priority Plan contents aligned for EMFAF.

CAP Strategic Plan (EAGF/EAFRD)

AGRI CSP (4687) - Sometimes changing the language did not load the translated labels in the selected language but fell back to default(en) language. This is fixed.

AGRI CSP (5925) - Missing links added between Specific objective and Type of intervention.

AGRI CSP (5876) - Corrected a translation of CZ for chapter 3.10.3.3.1.

AGRI CSP (6034) - during the 'prepare for send', the CSP report should be generated in native language(s) only.

AGRI CSP (6018) - Error when doing the RMR action (Return CSP to MS for Modifications with Remaining/Follow-up Observations). This is fixed.

AGRI CSP (6031) - Error when generating the excel report 6.2. This is fixed.

AGRI CSP (6054) - in section 4.2.1.4, the rule names is duplicated in table 'Categories of eligible farmers and other rules on allocations from the reserve. (Art. 26)'. This is fixed.

AGRI CSP (6022) - Modifying the PUA table when CSP is 'validated' doesn't trigger a status change in the workflow. This is fixed.

AGRI CSP (6059) - AnnexVI Sectors should have a unique Budget Code sequence across all Member States.

AGRI CSP (6063) – language was not properly set when creating budget codes nomenclature. This is fixed.

STD BAR (5816) - In edit mode when user selected "All countries" only one was displayed after save. This is fixed.

STD VTC (5909) – User was getting an error when trying to create & send the VTC document. This is fixed.
