PRG AIB (6652) - It must be possible to create a new Thematic Facility (TF) on an Adopted by EC (TF accepted) programme version in case no TF exists on that version. This can only happen on adopted 1.\* versions, where the TF was created against a previous 1.\* version.

AGRI CSP (6512) - Draft Annex Decision labels adapted.

AGRI CSP (6519) - 'National financial assistance in the F&V sector' estimated amounts table in annex V of the CSP added.

AGRI CSP (6513) - modification in table 2.3.2: apiculture output indicators values related to apiculture should now be the max instead of the sum.
