## Changes:

### ***Operational programme (IGJ)***

- OP IGJ (425048) - The validation rule 2.30 is changed and it only runs now when Union Support is > 0
  - *2.30 validate in Table 18a, that for non-TA priority axes, non-YEI Priority Axes/Funds with a Union Support (A) > 0, the "Performance Reserve amount as proportion per Priority Axis (L)" is between 5% and 7%. Doesn't apply for SME and TA Programmes (error)*

### ***Implementation Report (ALL)***

- IR ALL (423115, 422272, 422979, 422997, 423079, 422988) - A list of Validation Results were added in the print version for all the following documents in the Implementation reports: Snapshot of data before send, Acknowledgement of receipt and EC acceptance letter.

### ***Payment Forecast (EMFF,FEAD)***

- PF (425483) - A list of Validation Results were added in the print version for all the following documents in the Payment Forecast: Snapshot of data before send, Acknowledgement of receipt and EC acceptance letter.

## ***Documents***

- DOC (417679) - New features for document management are now implemented:
  - Allow to reply on a received document and to link these documents
  - Allow to restrict read permissions to only certain authorities and their equivalent roles, out of the role permissions set by the security system
  - Allow to acknowledge reception of a document
  - Allow to encrypt all files attached to a document

- Allow to validate the content of a document
- Force ECAS signature on send of certain documents
- Control possibility to hide an attachment

## **Defects fixed:**

### ***Rural development programme (EAFRD)***

- RDP EAFRD (387528) - There was a problem during the copy of a figure from previous to new version. This has now been fixed.

### ***Implementation Report (EGF)***

- IR EGF (425213) – For European Commission Users it is now possible to add a document during the Finish Winding up. The addition of the document is actually mandatory for the completion of the action.

### ***Evaluation Report (AMIF)***

- ER AMIF (423376) – The headings for columns (A) and (B) from annex table 1 were incorrect. This has now been fixed.
