Defects fixed:

Rural development programme (EAFRD)

- RDP EAFRD (422635) - The error "file is damaged and could not be repaired" was displayed when user was trying to open the programme PDF snapshot with Acrobat Reader XI. It worked though if the user generated the snapshot from the 'Print' button. This has now been fixed.

Designation of authorities

- DOA (429976) - The check boxes were not displayed correctly when Printed as Report. This has now been corrected.

Final Report (EGF)

- FR EGF (428333) - In the tables of Section 2.1 the totals for workers and NEETs should not appear as being editable. This has now been fixed.

Major Project

DOC – MP (430282) other member state document could not be created anymore. This is now fixed.

Financial data (IGJ,ETC)

- FD IGJ ETC (428056) - In the table 2 of the Financial data the thematic Objectives were not being filtered for Priority Axes as they were created in the programme triggering the errors from validation rules 2.11 and 2.16. This has now been fixed.

Evaluation Report (AMIF,ISF)

- ER AMIFISF (424398) – There was a Zero "{0}" inside the Header of the column "Total paid" of Table 1: Annex Data. This bug has now been fixed.

Documents

- DOC (429971) - The Non Integral document types were requesting the Ecas sign action when it shouldn't. This has now been fixed.
- DOC (430282) - The User was getting an error when trying to create a document type "Other Member State document". This has now been fixed.
