• IRA IGJ ETC EMFF FEAD IPACBC (425314, 424486) - The Irrecoverable Amounts are now implemented (new menu item under 'Execution').

# Financial data (IGJ,ETC)

- FD IGJ ETC (440699) The validation rule 2.17 is no more triggered for SME Programmes.
  - 2.17 validate in Table 2 for IGJ/ETC for ERDF/CF (non-SME) that codes are entered for Intervention Field, Form of Finance, Territorial Type, Territorial Delivery Mechanism, Thematic Objective (except for Technical Assistance Priority Axes), Economic Dimension and Location, and that ESF Secondary Theme is null (error) => "In table 2 for ERDF/CF, intervention field, form of finance, territorial type, territorial delivery mechanism, thematic objective (except for Technical Assistance Priority Axes), economic dimension and location are mandatory and ESF secondary theme must be empty"

# Accounts (ALL)

ACC (441338) - There is a change in the formatting of Section B, Payment table.

## Final report (EGF)

• FR EGF (441075) – Previously the notifications were sent to the emails of the persons designated as responsible for the implementation of the proposed actions (section A3). As some of the contact details are outdated and

there is no way of updating this information, the notifications are now sent to the Officials in charge emails instead.

## **Evaluation report (AMIF,ISF)**

• ER AMIFISF (436553) - The records of the Indicator Table (Section IX) are now, at the moment of the creation, automatically calculated and populated the Indicator Year columns for the H indicators.

#### LegisWrite

LGW (438520, 439738, 440298, 439493, 440283) - LegisWrite is a Commission Word plugin to make or convert
Word documents into Commission Decisions. It's that plugin that detects and determines to add a cover page
and to format the content of the Word document into LegisWrite format. All references to LegisWrite were
removed and a cover page is no longer automatically created and inserted. This is valid for objects like Accounts,
European innovation partnership and Evaluation Report.

# **Defects fixed:**

#### Instrument for Pre-accession Assistance in Rural Development (IPA-RD)

• IPA RD (440365) – There was an error generating the report for the Instrument for Pre-accession Assistance in Rural Development. This has now been fixed.

#### Transitory joint action plan

• JAP (439111) - While creating document if the User first add Links to the CCI and Update it and then later on Update it again to add an Ares document, an unexpected error occurred which blocked this document from being send. This has now been fixed.

#### Financial data (IGJ,ETC)

- FD IGJ ETC (440540) There was an error with validation rule 2.27 related to the 'Intervention Field' column without a Region Category. This has now been fixed.
- FD IGJ ETC (440028) There was an error with validation rule 2.20 because it was comparing the wrong columns.
   This has now been fixed.

#### Payment forecast (EMFF, FEAD)

• PF EMFF FEAD (440382) - There was an error with validation rule 2.29 related to the 'Intervention Field' column without a Region Category. This has now been fixed.

#### Quarterly declaration of expenditure (EAFRD)

• RDP DOE (440107) - The Paying Agency and Bank Account section were not automatically copying the information from the previous accepted declaration. This has now been fixed.

#### Accounts (AMIF,ISF)

 ACC AMIF ISF (441366) - The Payments data was not shown in the print of AMIF/ISF Accounts. This has now been fixed.

#### Accounts (EAFRD, EAGF)

- ACC EAFRD EAGF (438558) In the snapshot report, the logs files are no longer displayed and the attachment title (file name) is now displayed instead of only the file name as it should.
- ACC EAFRD EAGF (439858) In the search List view, the alphabetical sort of Paying Agency and the Paying Agency descendent was not working when the user clicked on the corresponding column. This has now been fixed.

## Annual control report (IGJ,ETC,EMFF,FEAD,IPACBC)

• ACR (438948) - The deleting of the last remaining version of a Control Report didn't delete the Control Report. This has now been fixed.

#### Final report (EGF)

• FR EGF (440313) - The notification emails were not working for Evaluation Report EGF. This has now been fixed.

# **Evaluation report (AMIF,ISF)**

 ER AMIFISF (440619) - The percentage for Technical Assistance was wrongly calculated in Table 1. This has now been fixed.
