## Changes:

### ***Implementation report (IGJ, ETC, IPA-CB)***

- IR IGJ ETC IPACB (446085) - There were changes requested from AIR2017 onwards:
  - 1. KEY Information filed is now mandatory in Section 3.1
  - 2. There are new validation rules in IR IGJ:
    - 2.57 *validate that Section 2 Overview of the implementation of the operational programme is not empty (Error)*
    - 2.58 *validate in Section 3.1 that for each Priority Axis the Key information field is not empty (error)*
    - 2.59 *validate that Section 4 Synthesis of the Evaluations is not empty (Error)*
    - 2.60 *validate when Programme contains YEI, that Section 5 Information on the implementation of the YEI is not empty (Error)*
    - 2.61 *validate that Section 6.a Issues which affect the performance of the programme and the measures taken is not empty (Error)*
    - 2.62 *validate that Table 12 on Major Projects contains all Major Projects (based on CCI) linked to this Programme (Error)*
  - 3. and the equivalent new validation rules in ETC and IPACBC:
    - 2.57 *validate that Section 2 Overview of the implementation of the cooperation programme is not empty (Error)*
    - 2.58 *validate in Section 3.1 that for each Priority Axis the Key information field is not empty (error)*

- 2.59 validate that Section 4 Synthesis of the Evaluations is not empty (Error)
- 2.61 validate that Section 5.a Issues which affect the performance of the programme and the measures taken is not empty (Error)
- 2.62 validate that Table 7 on Major Projects contains all Major Projects (based on CCI) linked to this Programme (Error)

### ***Annual Implementation Report (EAFRD)***

- AIR RDP (444198) - The following modifications related to FI (section 10) for the Annual Implementation Report 2017 were implemented:
  - in table 'Indicators'
    - a) M05 was added in measure list
    - b) dimension O1 (EIP) O1 (non-EIP) was added
  - 2) FI output indicator data provided under Section 10 was automatically transferred to Section 11
    - Section 10: Field 3.01 Commitments in Funding Agreements on measure and focus area level -> Section 11: Table A Commitments to FIs on measure and focus area level
    - Section 10: Field 41.2 Value achieved by FI in relation to the output indicators (MEASURE LEVEL) -> Section 11: Table B1, B2.1, B2.2 Transfer on measure level, automatic allocation to focus areas based on 3.01 (prorata) indicative allocations (also option for manual fill in)

### **Defects fixed:**

#### ***Operational programme (IGJ)***

- OP IGJ (455941) - There was an error when creating a new programme version. This has now been fixed.

#### ***Instrument for Pre-accession Assistance in Rural Development (IPA-RD)***

- PAP IPARD (454485) – There were irregularities and the adjustments made were not correctly displayed in the snapshot. Also the total EAFRD was not correct. This has now been fixed.
- PAP IPARD (454438) – There were wrong contribution rates (R) retrieved from FP. The column (R) should display the rates of column (6) 'Public expenditure EU contribution' of the programme FP. This is now the case.

#### ***Implementation report (ALL)***

- IR (446180) - Once Validations were done they have to be entirely visible on the "Version Information" page, however it was not possible to see all Validation errors because on this page there was no Scroll bars. Now the user can see all the Validation dialog box.
- IR (455889) – In Financial Instruments, the Field 1.1 (combo box) was not visible when values were long and the user could not use the scrollbar. Also the language of the values was the one related to the node instead of the one selected in the language settings. This has now been fixed.

#### ***Implementation report (IGJ)***

- IR IGJ (455639) - There was an error with the validation rule 2.62 that was also talking into account the approval date and wasn't taking into account the major Project Implementation Stage. This has now been fixed.
- IR IGJ (455767) - When selecting ATLSBS on section 14.4, the Table of contents for ATLSBS was created, but not the encoding pages for Relevance and Actions or Mechanisms. This has now been fixed.

- IR IGJ (455765) - The Validation rule 2.92 was wrongly triggered where Output Indicator was selected and the message was not correct because it mentioned "qualitative" instead of "quantitative". Also the validation rule 2.93 that should be triggered, wasn't. This has now been fixed.

### ***Implementation report (IGJ,ETC,EMFF,IPA-CB)***

- IR IGJ ETC EMFF IPACB (454317) - There were several fixes performed in the validation rules for financial instruments from 2.63 to 2.88).
- IR IGJ ETC EMFF IPACB (455741) - The validation rule 2.71 was triggered when it shouldn't. This has now been fixed.
- IR IGJ ETC EMFF IPACB (455580) - The changes in Financial Instruments of elements moved to Products were not implemented in the Print. This has now been fixed.
- IR IGJ ETC EMFF IPACB (428534) - On the creation of a new Implementation Report now the Financial Instruments data from previous years are correctly imported.

### ***Implementation report (AMF)***

- IR AMF (455382) – The table of contents in section 5 was missing a rich text field. This has now been fixed.

### ***Implementation report (IPA-CB)***

- IR IPA-CB (455584) - The printing of the report was failing. This has now been fixed.

### ***Implementation report (ETC)***

- IR ETC (454766) – There was an error in table 2 for the year 2017. It was only showing data from 2016 - 2014. This has now been fixed.

### ***Payment application (FEAD)***

- PAP FEAD (455633) – In the Print, the requested FEAD Amount was not visible. This has now been fixed.
