# Implementation report (IGJ)

- IR IGJ (11281) The validation rule 2.7.9 had CO18 and CO19 removed, and they were included in the new Validation Rule 2.7.13, only checking the cumulative values.
  - 2.7 validate in Table 4A per Priority Axis/Investment Priority/Category of Region that:
    - 2.7.9: the sum of CO01, CO03 and CO05 is higher or equal to figures for any of the common output indicators on participants (error)
    - 2.7.13: the sum of CO01, CO03 and CO05 for cumulative figures only is higher or equal to the cumulative figures for the common output indicators on participants CO18 and CO19 (error)

### Financial data (IGJ,ETC)

- FD IGJ ETC (11258) The validation 2.12 and 2.12.2 are now more detailed with the values from Table 1 and 2 that are different and the references to the Priority Axis/[Fund/Category of Region].
  - 2.12 validate in the IGJ/ETC, IPA-CB Payment Forecast for YYYY01 that the Financial Data in Table 2 per Priority Axis/[Fund/Category of Region] equals the Financial Data in Table 1 per Priority Axis/[Fund/Category of Region]

# Annual Implementation Report (EAFRD)

- RDP AIR (11272) The validation rule 580 was added for Financial Instruments:
  - EAFRD\_AIR\_AI\_580: validate in Financial Instruments for SF/FoF and SF, that elements , that elements 14.1.1; 14.1.2; 14.1.3; 14.1.5 and 15.1.1; 15.1.2; 15.1.3; 15.1.5 and financial products 25.1.1; 25.1.2; 25.1.3; 25.1.5 are empty (error)

#### **Defects fixed:**

### Operational programme (EMFF)

• OP EMFF (11250) - The Validation rule 2.31 should normally check that for measures with an updateable climate change rate, the rate is either 0 or 40. But this wasn't working properly. There were plenty of empty rates. This has now been fixed.

## Major project notification (Art.102(1) and 103)

• MP NOT (11266) – The user was getting an error when editing section A1, A3-A5 although the record was saved. This has now been fixed.

## Implementation report (IGJ)

• IR IGJ (11251) - The Validation rule 2.7.12 was triggered when in Table 4A the achievement values were 0, but the rule should only check that they are not null. This has now been fixed.

## Annual Implementation Report (EAFRD)

- RDP AIR (11257) An European Commission user was able to edit the result indicators table (section 7) when it should not be the case. This has now been fixed.
- RDP AIR (11259) In the snapshot report, the section 1b and the Annex II were displaying planned values from an old version of the Rural development programme, with measures that were removed during an amendment. This has now been fixed and now the system displays the planned values from the Rural development programme linked to the current Annual Implementation Report.
- RDP AIR (11222) The editing of the introduction table in section 10 didn't trigger the change of the status in workflow back to 'Open' like it should. This has now been fixed.
- RDP AIR (11278) When the user validates the Annual Implementation Report, the system displayed first an error message 535 for only one of the Financial Instrument, but when the user would fix the error for this one Financial Instrument and revalidate again, it would show the same error 535 again for the next Financial Instrument. This has now been fixed and all messages for the Financial Instruments are displayed at once.
- RDP AIR (11109) The disclaimer for table F (Performance) should not be displayed in Annual Implementation Report Rural Network Programme. This has now been corrected.
