#### Implementation report (EMFF)

• IR EMFF (11422) - When in compare mode, there were differences in Section 3.2 - table 1. The result indicators have the red asterisk indication in the Table of contents but no differences in detail. This has now been fixed.

• RDP AIR (4666) – There was a problem during the report generation as the system missed to copy a figure from a previous version to the new version. This has now been fixed.
