New Functionalities:

Applied validation rules

- VAL (1211,1213,1214) - There is a new report called "Applied validation rules" under the print menu of all object versions.

Performance review decisions

- PRD (10405,10477) - There is now under menu option "Monitoring" and the item "Performance Review", a new sub-item called "Performance Review decisions" managing those type of documents. A quick guide for this functionality can be found [here](#).

Changes:

Major project notification (Art.102(1) and 103) & Major project submission (Art. 102(2))

- MPN MPS (10386) - There is a new action for the commission user "Acknowledge" and a new status "Acknowledged by EC" for both Major project notification (Art.102(1) and 103) and Major project submission (Art. 102(2)). There is also a new document type "EC acknowledgment comments" to be optionally sent with the acknowledge action.

Commission decision

- CD (10273) - A few modifications were added to the commission decision:
 - The decision information edit screen now has a new combo box for "Is correcting decision".
 - The decision information display screen has a new field "Is correcting decision" and the "Corrected by decisions" hierarchical list was also added.
 - The search screen was modified by adding the hierarchical list icon and popup after each decision that has at least one corrigendum linked.

- The search screens and General Version Information screens of objects having a Commission Decision column were modified to include the hierarchical list icon and popup. (Partnership Agreements, Programmes, Major Projects, Accounts).

Accounts (AMIF,ISF)

- ACC AMIF ISF (10568) - The validation rule 2.58 has been lowered to a 'Warning' and the validation rule 2.64 was added:
 - *2.64 - validate on PR Projects that the Keyword / Specific Objective combination exists in Project Keyword Specific Objective (error)*

Print

- PRINT (10634) - There was a change in the design of the validation results and validation rules in the print. It was compacted by removing 6 points in the above and below lines and the font size was changed from 12pt to 8pt.

Defects fixed:

Partnership agreement

- PA (10641) - The user wasn't able to create a new version of a Partnership Agreement with status "Withdrawn at the request of the MS" as the action link did not appear. This has now been fixed.
- PA (10644) - Previously, if a Member State user created a new version just after the object is set on status 'Withdraw at the request of MS' the European Commission User was still able to reopen it although he shouldn't be allowed. This has now been fixed.

Commission decision

- CD (10272) - On The main search page of the Commission decision object, the "Covered CCIs" column was empty though the commission decision itself contained the CCI number's in the section "Covers". This has now been fixed.
- CD (10666) - There was a server non-stop Loop when Decision A was defined as corrected by Decision B and then also in B it was defined as corrected by A putting down the entire system into non-accessible situation. This has now been fixed.
- CD (10668) - When a Commission decision A was corrected by B, if the User tried to delete Commission decision A the system would give an internal error. This has now been corrected with a proper error message.

Financial data (IGJ,ETC)

- FD (10620) - The upload of an Excel file in the Table 2 was giving an out of memory error. This has now been fixed.

Implementation report (IGJ,ETC)

- IR IGJ (10571) - The Columns 13 and 14 were present for the all years but they should be only displayed for the year 2018. This has now been fixed.
- IR IGJ (10572, 10573) - The Tables 2C and 22 weren't appearing in the Table of Contents in the print version. This has now been fixed.

Annual control report (IGJ,ETC)

- ACR IGJ ETC (10500) - When the Member State user created a new version of the Annual control report after the last one had status "Complete assessment with observations", the European Commission User did not see any more Links on the top to perform the "Set Modifiable" elements. This has now been fixed.
- ACR IGJ ETC (10677) - In the "ANNEX 4 - AUDIT FINDING" it was not possible to insert data for two different funds with the same Subcategory. This has now been fixed.
