## New Functionalities:

### *Accounts (AMIF/ISF)*

- A Quick Guide is available on the portal via the **SUPPORT MATERIALS MS** -> Execution -> Accounts (AMIF/ISF) menu.

## Changes:

### *National Programme (AMIF/ISF):*

- NP AMF/ISF - Split Transfer into Relocation and Transfer

### *Designation of Authorities (EAFRD):*

- DOA: Add EAFRD programmes for the RP, NP and RN Programmes

### *Payment Application:*

- PAP - cancel not working when a previous working version was Returned for Modification by the Commission.

### *Payment Application (IGJ/ETC/FEAD):*

- PAP and PAPFEAD: New validation rule checking that Total eligible expenditure is >= Total public expenditure
  - For PAP: 2.13 validate in the Expenditure table, that the Total amount of eligible expenditure is >= Total amount of public expenditure (error)
  - For PAPFEAD: 2.17 validate in the expenditure table of OP I and OP II, that the Total amount of eligible expenditure is >= Total amount of public expenditure (error)

## **Defects fixed:**

### ***Partnership Agreement:***

- PA - Validation rules 2.12 and 2.13.1 wrongly implemented
  - Validation error 2.12 "No poverty actions are defined against CCI {0}." Was triggered when there was no record in PovertyActions for each of the CCIs used in paragraph 1.6.
  - Validation error 2.13.1 "All 9 performance reserve records should exist." was triggered even when those 9 records exists in paragraph 1.10 PerformanceReserveAllocation

### ***RDP:***

- RDP: Error FBM-002 because some financial values in database were not displayed in the screen (section 10.3)
- RDP: couldn't delete Additional Focus Area if an Ex Ante Conditionality was linked to it
- RDP: Validation rule 106 was not triggered when the total annual contribution 10.1 was different from the total contribution of all measures 10.3

### ***Programme (ISF):***

- PRG ISF - An error was occurring when updating table2-police when no objective/action of SO5 or SO6 was selected in the coverage section
- PRG AMIF/ISF - When editing AMIF Table 1 or ISF Tables 1 or 2, the table was duplicated

### ***Programme (AMIF):***

- PRG AMIF - Special cases sections - The user could not enter values in columns he was supposed to be able to: Eg : A programme created in 2015: values in columns 2014 and 2016 should be editable. But only column 2014 was enabled.
- PRG AMIF/ISF - When editing AMIF Table 1 or ISF Tables 1 or 2, the table was duplicated
- PRG AMIF - Validation rule 2.12 was checking against a wrong creation year
- PRG AMIF - Table 1 - The total special cases was not taking into account the amount relative to Transfers

### ***Payment Application:***

- PAP IGJ/ETC, EMFF, FEAD - Some texts were not correct in the screens
- PAP - create Final Payment only possible after end of declaration period, no cancel possible for Final Payment

### ***Payment Application (FEAD):***

- PAP FEAD (FM) - The total values in Expenditure section was incorrect.
