# **Defects fixed:**

## Implementation Report (IGJ)

- IR IGJ Table 4A It was not possible to update the table when values introduced for common output indicators without gender breakdown or in grand totals were bigger than a certain value.
- IR IGJ Indicator tables did not show all relevant years. For a 2015 IR, the reporting year and the past years were not always displayed in the Indicator tables. Table 1 and 2C only showed 2014. Tables 3A and 2A only showed 2015. 2B YEI didn't show all years.
