Annual Implementation Report (EAFRD)

- AIR EAFRD - Snapshot section 1.b) Common and programme-specific indicators and quantified target values was implemented
- AIR EAFRD - User is now allowed to create specific output and target indicators directly in section G of the Annual Implementation Report.
- AIR EAFRD - Maximum characters number increased (3500->7000) for section 3a1 for NRN programmes.

Implementation Report (IGJ)

- IR IGJ - New validation rules (2.31 to 2.34) making annual values for Tables 2A, 2B and 4A mandatory for ESF common output and result indicators in line with Article 5 of the ESF Regulation. The user must report at least 0. This applies to Tables 2A and 2B (common ESF and YEI result indicators) as well as Table 4A (ESF output indicators), for values provided in gender break-down (columns M and W) and without gender break-down (rows for CO20, 21, 22 and 23, i.e. the common output indicators for entities). The following validation rules were added:
 - 2.31 *validate in Table 2A that the annual Men and Women columns are not null for years <= reporting year (error)*
 - 2.32 *validate in Table 2B that the annual Men and Women columns are not null for years <= reporting year (error)*
 - 2.33 *validate in Table 4A that the annual Men and Women columns are not null for Common Output Indicators CO01 to CO19 and years <= reporting year (error)*

- 2.34 validate in Table 4A that the annual Total columns are not null for Common Output Indicator CO20 to CO23 and years <= reporting year (error)

Defects fixed:

National Programme (AMIF, ISF)

- NP AMFISF - New validation rule 2.18.4 prevents the creation of timetable action names with only a blank character

Implementation Report (IGJ/ETC/EMFF)

- IR - For financial instrument the edit buttons were visible even when the object was not editable
- IR - Financial instrument: When the user had on section 4.1 a CCI already selected and clicked on the button, the selected one were not in the right column. The column on the right was empty. Now the user is able to see the selected ones.
- IR - When a new implementation report version was generated for IGJ/ETC/EMFF, the table of contents items under financial instruments was not generated.

Implementation Report (IGJ)

- IR IGJ - Validation rule 2.9 was incorrectly displayed and it was triggered even when it wasn't applicable.
- IR IGJ – Validation rule 2.7.9 says: the sum of CO01, CO03 and CO05 is higher or equal to figures for any of the common output indicators on participants (= CO01 to CO19) but it was also triggered for Common Output Indicators (i.e. CO20).
- IR IGJ – When creating the Implementation Report an error occurred when Table 4 in the related programme (ESF) contained a result indicator duplicated and without "common indicator used as basis" selected.
- IR IGJ - On Validate, an unexpected error occurred when there were too many validation messages. This has now been fixed.
- IR IGJ - On Validate, an unexpected error occurred when the validation rule 2.17 was triggered.

Implementation Report (EMFF)

- IR EMFF - The fund in financial instrument is now automatically selected as EMFF
- IR EMFF - Not all Actions related to non-fulfilled criteria's were displayed in Table 6.

Implementation Report (ISF)

- IR ISF PRINT - The first element "Provide an overview of the implementation of the Special Transit Scheme in the financial year. Provide any changes to the strategy or altering factors that may lead to changes" of Section 4 was missing in the Print while the second element "List the main actions supported and carried out over the financial year, successes and problems identified (and resolved)" was only partially displayed. This has now been fixed.

Implementation Report (AMF)

- IR AMF - Fields that were missing in the report had now been added.

Annual Implementation Report (EAFRD):

- RDP AIR – It was not possible to create an Annual Implementation Report in case some related Bi-annual indicator data provision rows were null.

Rural Development Programme (RDP):

- RDP – Issues with sending a programme to the EC have been fixed.

Standalone/ Referring Documents

- DOC - Country was not being set at creation time of an integral document, while it should always be filled in with the Country of the Node creating the document.
