### ***Rural Development Programme (EAFRD)***

- RDP EAFRD (359923) - Validation rule added which prevents the MS from removing a budget code line from the RDP FP, if some expenses have already been declared for this line by the MS in the past DOE(s):
  - *Message = The budget code line {0} has been deleted whereas expenses exist for this line in a past accepted Declaration of Expenditure*

### ***National Programmes (AMIF)***

- NP AMF (366323) - CH, NO, IS and LI added to countries that will receive applicants from Relocation 2015/1601 and 2015/1523
- NP AMF (364762) - A new Special Case type has been created for the Admission from Turkey (amendment on 2015/1601).
  - *Changes in validation rules 2.7, 2.12, 2.13, 2.28*

### ***Accounts (AMIF)***

- ACC AMF (365180): - A new Special Case type has been created for the Admission from Turkey (amendment on 2015/1601 = 2016/1754). This includes the following Validation Rule changes:

- Validation rule 2.11 validate that the Accounts version contains all Projects without Final Payment created in previous Accounts versions independent from the Financial year and for AMIF, all Special Cases Projects (RP, RO, ST, AD) for which the pledging period is still active (In 2015, the 2014 Projects, in 2017, the 2016 Projects and in 2019 and in 2020, the 2018 Projects) (implicit in web) (error)
- 11. Validation rule 2.47 validate that Admission, Transfer and Relocation types used in Admission, Transfer and relocation Pledges exist in the linked Programme version. (error)

### ***Accounts (AMIF/ISF)***

- ACC AMFISF (364055) - Two new fields added on PR Projects: "Project duration (months)" and "Estimated Total EU contribution" on "PR "Projects.
- ACC AMFISF (364061) - Creation of Accounts N from 16/10/N-1 onwards is now allowed.

### ***General (Documents)***

- DOC (364831) - Unsent non-integral documents will now be highlighted on the display screen to make it clear to the user that these documents still need processing.

### **Defects fixed:**

#### ***Rural Development Programme (EAFRD)***

- RDP EAFRD (364724) – it was not possible to add an amendment description in some cases. This is now fixed.

#### ***National Programme (ISF)***

- NP ISF (365274) – timetable was in the wrong order, section 4 fields were truncated when " was included in the text. This is now fixed.

#### ***Payment Application (All Funds)***

- PAP ALL 366637) – It was impossible to create new PAP if the Adopted Programme Decision date was greater than today. This is now fixed.

### ***Accounts (AMIF/ISF)***

- ACC AMFISF (366311) - section III.C Overall summary of financial on the spot controls on finalised projects in year YYYY should now include all finalized projects.
- ACC AMFISF (364432) - section III.C annual summary > operational on-the-spot controls - column B was not displaying the correct value.
- ACC AMFISF (367103) - Validation rule 2.46 was triggered when there was no quota for the year of the accounts version. This is now fixed.

### ***Accounts (AMIF)***

- ACC AMF (367072) - When Validating Accounts the user was receiving a blocking error. This is now fixed.
