#### **Print in Word**

- PRINT Member State users now have the option to print the following object types in Word:
  - 1. PA
  - 2. Application EGF

## **Changes:**

### Annual Implementation Report (EAFRD)

- AIR EAFRD Tables G1 and G2 in the Annual Implementation Report are now sorted without differences between the template and the snapshot generated.
- AIR EAFRD Snapshot section 1.b) Common and programme-specific indicators and quantified target values was implemented
- AIR EAFRD The following validation rules were added/
  - In case the MS uses FI (art 59(4)(c) or art 59(4)(d)), validate that at least the "Report on the implementation of financial instruments" is annexed to the AIR (Error)
  - validate that at least one "Financial annex (system or other)" is annexed to the AIR (error)
  - validate that a "Citizen's summary" is annexed to the AIR (warning)
  - validate that all integral documents have at least one attachment with a length > 0 (error)

- validate that at least one official in charge of the Member State exists (warning)
- validate that the "Monitoring committee approval date" is filled. (warning)

#### **Annual Implementation Report (EAFRD)**

- AIR EAFRD The cumulative Declarations of expenditure is now correctly calculated in section 3b, taking all
  accepted Declarations of expenditure for this programme (before the end of the Annual Implementation Report
  implementation period).
- AIR EAFRD Acknowledgement of receipt for the Implementation report was not generated correctly.
- AIR EAFRD Monitoring table B1 is now always displayed in the snapshot.
- AIR EAFRD Monitoring structure code is now set as cell-id and also as name for all textbox in tables from A to E.
- AIR EAFRD New template available for the document type "Report on the implementation of financial instruments".
- AIR EAFRD If an Annual Implementation Report was 'Ready to send', and the user did any update on section 11, an error was changing back the status of it to 'Open'. This has now been fixed.

## Declaration of Expenditure (EAFRD)

## **Designation of Authorities**

 DOA - Validation Rule 2.1.3 will only trigger when Designation end date is equal to the current date (as well as smaller).

#### Implementation Report (IGJ/ETC/EMFF)

- IR The table of content item for Financial Instruments now includes the Priority Axis (IGJ/ETC) or Union Priority (EMFF) code before the name. E.G. PACODE Name of Financial Instrument.
- IR Financial Instruments long name are now entirely visible.
