## **Defects fixed:**

### **Annual Implementation Report (EAFRD)**

- AIR EAFRD - Security verification on workflow restrictions was updated so that the user is now warned with an error if he doesn't have the permission to edit the programme version.

- AIR EAFRD - Consistency display between the text and the text area was improved (e.g. section 6.2)
- AIR EAFRD - In section 11.1, on target indicators table, empty values are now displayed as '0.00' not only in comparison mode but also in normal mode.

### ***Implementation Report (IGJ)***

- IR IGJ PRINT - Missing years 2019-2023 for table 4A and total column are now included.
- IR IGJ PRINT – Missing column 'Measurement unit' is now included in table 2c as well as '2014' for version 2014. The display of the '%' sign was also corrected.
- IR IGJ – In table 2B, the calculation for the achievement columns is now correctly multiplied with 100 and the 'Measurement unit' for baseline and target column shows now "Ratio" and "Number" like in the other tables.
- IR IGJ - Table 2C is now sorted correctly based on the 'Order by' number the user entered for each indicator.
