- IR EGF - Final Report (EGF) is now available.

Annual Implementation Report (EAFRD)

- AIR EAFRD - The following validation rules were added:

Application (EGF)

- APP EGF - The calculation of the activities' eligibility was changed in the following way: from End date = (latest of earliest start date of activities and application version 1.0 sent date) + 30 months to End date = (latest of earliest start date of activities and application version 1.0 sent date and earliest start date of measures) + 30 month

Implementation Report (IGJ/ETC/EMFF)

- IR - Implementation of the compare mode for financial instruments.

Implementation Report (FEAD)

- IR FEAD – Programme-specific indicators created in previous Reporting Years cannot be deleted and only the baseline value, target value, the order by and the annual values can be updated.

Payment Application

- PAP - Sending a new Final Payment Application is no longer blocked when all previous versions are 'Sent' to the commission. The previous pre-condition: "When creating a new Final Payment Application, all existing versions (last working version) for the same CCI and Fund must be 'Cancelled' or 'Fully Rejected by EC' or 'Accepted by EC'." was changed to "When creating a new Final Payment Application, all existing versions (last working version) for the same CCI and Fund must be 'Sent' to the Commission, 'Cancelled' or 'Fully Rejected by EC' or 'Accepted by EC'."

Rural Development Programme (EAFRD)

- RDP – User is now able to upload the documents of the previous version by clicking on an import button for all EAFRD objects (PRG, DOE, BAIDP, AIR).

Annual Implementation Report (EAFRD)

- AIR EAFRD PRINT - "DM" now appears in front of Discontinued Measure in snapshot report table E.

Application (EGF)

- APP EGF -It is now possible to add the same company for 2 different regions in section C.

General

- Statuses of different objects were not in line with the workflow. Although everything else was performed correctly, the status was remaining with an old value. This has now been fixed.

Implementation Report

- IR - The error causing that the Specific Indicators were removed from the financial instruments when the validation rule 36 was executed is fixed.

Implementation Report (IGJ)

- IR IGJ PRINT - Table 2C is now sorted correctly based on the 'Order by' number the user entered for each indicator. Measurement unit for indicator and measurement unit for baseline and target are now populated with programme values.
- IR IGJ - In table 12, the list boxes for Status and Stage was showing already a default value when entering for the first time in this table. This has been corrected.
- IR IGJ - An error was occurring when trying to delete a Financial instrument > Thematic objective
- IR IGJ - When creating a new Implementation Report version, the financial instrument Specific fund of "Fund of funds" was shown, in compare mode, out of section 8 - financial instruments in the table of content. This has now been fixed.

Implementation Report (EMFF)

- IR EMFF - Editing table 1 with 5 decimals no longer gives an error.
- IR EMFF - The union priority code was added to the table of contents item name in the Financial Instruments. This should work when a new Financial Instrument is created, and also when a new version is created.

Operational Programme (IGJ)

- OP IGJ - When updating the "Operational programme > S7 Authorities and Bodies > Table 23: Relevant authorities and bodies" by adding a new authority there is no longer a space filled by default in the email field.

Rural Development Programme (EAFRD)

- RDP - Amendment section is now empty in case of a new version that occurs after adoption of the previous one.
- RDP - Difference between Table of Content and Table for amendment description no longer exists.
- RDP - Each time a new version of a NF is created, data of tables 4 (Annual Financial Plan by Regions) is now automatically retrieved from last adopted program (section 10.1) based on regions presented in section 2.1 of NF. Selection of articles is not needed anymore in table 4 of NF.
