 - 2.12 *Validate for IGJ/ETC/EMFF DOAs that when DoA version = 1.n and when "Submission under Article 124(4) CPR" checkbox is not ticked and previous version is not in status "Documents requested by EC ", that none of the 3 documents "Report by Audit Body" (DOA.REP), "Opinion by Audit Body" (DOA.OPI) and "Description of Functions and Procedures" (DOA.FAP) are uploaded (error)*

 - 2.23 *validate in 3.1 for workers that the number of women in each category exceeds neither the total number of women nor the total number of workers of the same category (error)*
 - 2.24 *validate in 3.3 for NEETs that the number of women in each category exceeds neither the total number of women nor the total number of NEETs of the same category (error)*
 - 2.25 *validate in 3.1 for workers that for categories 'Workers with a longstanding health problem or disability', 'Self-employed' and 'Inactive in education or training' that the number of women is not empty if the respective number of workers is not empty (error)*
 - 2.26 *validate in 3.3 for NEETs that for categories 'Self-employed' and 'Inactive in education or training' the number of women is not empty if the respective number of NEETs is not empty (error)*

Designation of Authorities

- DOA (386526) - Compare - An error was occurring when clicking on Authorities section in compare mode. This is fixed.

- IR IGJ (383433) - Table 15 Criterion fulfilled was showing true/false instead of yes/no

- IR AMFISF (385344) - Error related to transfer and relocation fixed

Payment Application

- PF (387031) – List Of Persons In Charge for PAPs were showing all the officials no matter the fund (this is now fixed).

Financial Data (IPACBC/SFCF)

- PF IPA CBC (386816) - table 2 now reads thematic priority and not thematic objective
- PF IPACBC, SFCF (384192) - when importing the excel for Table 2 in PF IPACBC, SFCF the thematic priority/thematic objective were required fields but an empty value is now allowed as in the web form.

Accounts (IGJ)

- ACC SFCF ETC EMFF FEAD (387046) – Error when editing some of the audit opinion sections has been fixed

Annual Control Report

- ACR (384905) - Validation rule 2.8 will only verify within the same reporting year:
 - 2.8 *validate that the Programmes covered, only exist in one non-cancelled Annual Control Report of the same Year and with the same Annual Control Report ID (warning)*

Documents (EC Users only)

- Documents – When EC User was entering Ares number in "Commission Reference" the user was still able to see the add section to manually add a document but clicking on the add button would cause an error. The EC User will no longer see the Document Add section when an Ares document has already been retrieved.
