Changes:

Partnership agreement

- PA (401995) - New Post conditions on the Send action: on success, the Partnership Agreement is sent to the Commission. However, when it concerns a Major modification (Section 1 or 2 is modified) or a semi-structured Partnership Agreement, then status is set to 'Sent' instead of 'Adopted by MS'. On sending of the Partnership Agreement to the Commission it can only be set to 'Adopted by MS' when sections 1 and 2 are not modified and when it concerns a fully-structured Partnership agreement.

Operational programme (IGJ, ETC, EMFF, FEAD, IPACBC, AMFISF, APEGF)

- OP (401569) - Currently, when creating a new version based on the withdrawn version, the working version number increases. This was modified so that it is the major version number that gets increased. Therefore, the version is incremented by one (ex. 1.0 -> 2.0) when the status of the last version was 'Withdrawn at the request of the MS' and the user has chosen to create the new version based on the withdrawn version or on the last adopted version.

Rural development programme (EAFRD)

- RDP AIR (380593) - Structured financial instrument (section 10) is now implemented
- RDP AIR (397510) - Financial Instrument section was adapted and improved:
 - When a user adds or edits a row of the Thematic objectives, the field 3.01 is computed and this value remains in the object.
 - For section 30A there is no longer the option (yes/no) to be checked by default
 - When the user adds/removes some measures in field 1.1, he is no longer forced to update the whole form in order to continue filling the amounts in others fields that depend on these measures (i.e 14.1.4)
 - Titles on pop-up windows were added
 - Useless fields are no longer displayed
- RDP AIR (400643) - The user is now allowed to add some structured table in the rich text component
- RDP AIR (400613) – Characters limit were increased for field 1c) "key information" (from 70000 to 100000)
- RDP AIR (380598) - A few changes are now in place:
 - A) Monitoring (section 11)
 - B) Financial instruments (section 10)
 - C) Evaluation (section 7)

Implementation Report (IGJ)

- IR IGJ (393732, 393733) - A few changes are now in place:
 - New validation rules,
 - Changes in Table 2C,
 - Achievement ratio as nominal value is always shown
 - Table 5 Performance Framework Indicators.

Implementation Report (IGJ/ETC)

- IR IGJETC (394630, 394633) - A calculated table on Climate Change contributions was added to Section 11.4 IGJ and Section 9.4 ETC.
- IR IGJETC (390419) - Rich text on the contribution to macro-regional and sea basin strategies was replaced with structured data for IGJ section 14.4 and ETC section 11.3 (Both for web and print).

Implementation Report (FEAD)

- IR FEAD (394349, 394343) - A few changes are now in place (Both for web and print):
 - Replace Measurement Unit “Yes/No” checkbox in OP I Output Indicators by “Yes/No/Blank” List box.
 - When past year’s achievement values are modified, a warning is displayed (in validation).
 - Additional (2.13, 2.14, 2.15, 2.16, 2.17), obsolete (2.5.1, 2.8) and modified validation rules (2.5.2, 2.7, 2.9, 2.10, 2.11).
 - Table of content Item label ‘2.2 Actions’ was changed to ‘2.2 Horizontal principles’
 - It is now allowed in OP II Programme Specific Quantitative Output and Result Indicators, to encode the Cumulative value and the Achievement Ratio

- It is now allowed in OP I Common Output Indicator Food to encode the Cumulative value when Measurement Unit = %

Payment application (FEAD)

- PAP FEAD (387980) – Programme version was added in Print

Defects fixed:

Rural development programme (EAFRD)

- RDP AIR (399965) - When user created a specific target in table G1 or output in table G2 which is not in the Rural development programme, it was still referring to 2015 value (instead of 2016) and on top of that, when the user edited it, the cell was called 'planned output' or 'target value 2023' when it should be 2016 value for both National programme (AMIF and ISF). This has now been fixed.

Major project submission (Art. 102(2))

- MP (395879) - In Print, the text content of the old attribute Major Project Submission Section F in Annex Two was repeated under new project table. This has now been fixed.

Commission Decision

- COMDEC (400468) - When linking a major project to a commission decision this linked major project could not be seen under the commission decision. This has now been fixed.

Implementation Report (IPACBC, ETC, IGJ)

- IR IPACBC ETC IGJ (401706) – Validation Rules 2.37, 2.38, 2.39, 2.40, 2.41, 2.42, 2.43 were not implemented at all although they should have been in place. These Validation Rules are now ruling.
- IR IPACBC ETC IGJ (401725) – Before, when the user answered ‘Yes’ to question C, the text box answer field related to question on future investments was not shown. Now also the question itself will not be shown to avoid confusion.

Implementation Report (IGJ)

- IR IGJ (402138) - Automatic calculations from Tables 2A, 2B, 2C, 4A and 4B in to Performance Framework table 5 were wrong. This has now been fixed.

Implementation Report (ETC)

- IR ETC (400972) - The column "Fund" for Implementation Report ETC Table 5 is now hidden as it should never been shown.

Implementation Report (ETC)

- IR ETC (400600) – The Search engine was sometimes returning empty results when there should be data displayed. Also ordering by Reference and title were not available. All this is now fixed.

Implementation Report (IPACBC)

- IR IPACBC (401124) – General defects were fixed.

Payment Application

- PAP ALL (375575) - Banking information was empty under Application for Payment. Now when for the same fund the Banking information was already submitted in previous Payment Applications period, then the same Data is automatically filled in the new Payment Application version and for any Next X version.

User Preferences

- (400751) Under the menu option Utilities, there is one object called “User preferences” which when selected displays 3 different tabs. In the tab “Delegations” if the User clicked on 'Edit delegation' he gets some information but no data is shown for 'Delegated Role - Fund' field. Now this is fixed.
