Changes:

Application (EGF)

- AP EGF (404298, 404308) - Now in the Application (EGF) Section G.1.1, the columns related to Targeted young persons not in education, employment or training (NEETs) and beneficiaries are only displayed when NEETs are present.

Partnership agreement

- PA (403644) - The status to 'Adopted by MS' is now disabled in SFC2014.

Implementation Report (IGJ)

- IR IGJ (400797) - Formulas for Tables 8 and 9 were modified.

Implementation Report (IGJ/ETC)

- IR IGJETC (390416, 390419) - Rich text on the contribution to macro-regional and sea basin strategies was replaced with structured data for IGJ section 14.4 and ETC section 11.3 (Both for web and print).

Implementation Report (EGF)

- IR EGF (404055) - A non-integral document type "Opinion by audit body" (IR.OPI) is now available and a validation rule was added to check if such document was uploaded in SFC2014.
 - *2.27 Validate that for version 1.0 the 'Opinion by Audit Body' document was uploaded in the system (Warning).*
- IR EGF (403612) - The layout of the table in Section 2.1 was changed in Print.

Implementation Report (EMFF, ETC, IGJ)

- IR EMFF ETC IGJ (398801) - A few modifications have been set for the Financial Instruments in the Implementation reports for IGJ, ETC, EMFF and IPACBC:
 - Fields 29a, 29a.1 - 29a.9, 29a.9.1 were removed from the edit page, display page and print. These fields were at the level of the Financial Product.
 - A new formula is now in place for the calculation of the Achieved leverage 39.2.
- IR EMFF ETC IGJ (403189) - Financial Instrument got changes in print.

Annual Implementation Report (EAFRD)

- RDP AIR (336401) - A new Validation Rule was created to prevent the Member State to submit their Annual Implementation Report to the European Commission before the 1st June 2016. The message text is: "The submission of the Annual Implementation Report to the European Commission in SFC2014 will be opened starting from the 1st June 2016"
- RDP AIR (402621) - The user is now allowed to populate monitoring values (section 11, tables A->F) by uploading an Excel file (.xls).
- RDP AIR (380593) - Structured financial instrument (section 10) is now implemented.
- RDP AIR (403281) - Annex 3 is now implemented in the Annual Implementation Report snapshot report.
- RDP AIR (397510) - Financial Instrument section was adapted and improved:
 - When a user add or edit a row of the Thematic objectives, the field 3.01 is computed and this value remains in the object.
 - For section 30A there is no longer the option (yes/no) to be checked by default
 - When the user add/remove some measures in field 1.1, he is no longer forced to update the whole form in order to continue filling the amounts in others fields that depend on these measures (i.e 14.1.4)
 - Titles on pop-up windows were added
 - Useless fields are no longer displayed
- RDP AIR (371296) - New validation rules were implemented:
 - *2: Implementation report version has been validated. (Info)*
 - *10: Validate that at least one official in charge of the Member State exists. (Error)*
 - *30: Validate that the 'Monitoring committee approval date' is filled. (Warning)*
 - *60: Validate that at least one Financial annex (system or other) is annexed to the AIR. (Error)*
 - *70: Validate that a "Citizen's summary" is annexed to the AIR. (Warning)*
 - *80: Validate that all integral documents have at least one attachment with a length > 0. (Error)*
- RDP AIR (402504) - The layout for indicators Overview tables (main and details) was improved in the snapshot report: section 1b (overview main) and annex II (overview details).

- RDP AIR (404458) - A new validation rule was created to verify if the (system) Financial Annex is up-to-date:
 - *Code 61 - Error message: the Financial Annex generated by the system is out of date, please refresh it to get the last version (section General>Documents)*

Accounts (IGJ, ETC, EMFF, FEAD, AMIF, ISF)

- ACC IGJ ETC EMFF FEAD AMIF ISF (402045) - The linked commission decision documents is now shown in the Documents list.

Defects fixed:

Partnership agreement

- PA (404903) – Users were unable to validate Partnership agreement due to error with validation rule 2.6 'empty state' condition.

Operational programme (IPACBC)

- OP IPACBC (402914) - Thematic Priority description in section title was not translated. This has now been fixed.

Major project submission (Art. 102(2))

- MP (404708) - There was an error when sending the Major project submission. This has now been fixed.

Major project notification (Art.102(1) and 103) & Major project submission (Art. 102(2))

- MP MPN (404964) - There was an error with section C.3 as the calculated field 3 was only taking 2 decimals from field 2. This has now been fixed.

Application (EGF)

- AP EGF (403568) - In section C it is now possible to introduce the name of the same enterprise multiple times for different methods of redundancies. This also applies to all intervention criterion types.

Commission Decision

- COMDEC (382918, 392027) - The Link to Commission Decision dialogue was not being displayed fully in a few objects. This has now been fixed.

Implementation Report (IGJ)

- IR IGJ (403120) - When "Fund of Fund - Specific Fund" contain amount in 14.1 then this amount should not trigger VR2.19 as it was happening because there is no Thematic objectives for this "Fund of Fund - Specific Fund". Only "Fund of Fund" has thematic objective linked and required to trigger VR2.19. This has now been fixed.
- IR IGJ (400480) - Table 1, Table 5 and ex-ante conditionalities tables (section 13) were not shown in the report. This has now been fixed.

- IR IGJ (404765) - Table 4B was displayed in a wrong order. Now it is on the correct order: PA/IP/ID/Category of Region

Implementation Report (EMFF)

- IR EMFF (337220) – The data from the Table of Contents items 3.2, 11.1 and 11.2 was not sorted in ascending order in the Printed Report. This has now been corrected.

Implementation Report (FEAD)

- IR FEAD (404911) - There was an issue with Validation rule 2.15. This has now been fixed.

Annual Implementation Report (EAFRD)

- RDP AIR (402495) - In section 7, the Quantitative values rows were not deleted when Judgment Criteria Linked to them were removed. This has now been fixed.
- RDP AIR (403333) - There was an error in section 7 when importing a value from the programme for a common context indicator. It only happened when the selected language was not English. This has now been fixed.
- RDP AIR (404400) - There was an error when deleting a communication act. This has now been fixed.
- RDP AIR (403257) - Missing content in section 5 of main snapshot report was added. The layout was also improved.
- RDP AIR (403248) - In section 7, the indicator code R2 AWU was appearing twice in quantitative values table and this was causing an error when editing. This has now been fixed.

Payment Application

- PA ALL (375575) - Banking information was empty under Application for Payment. Now when for the same fund the Banking information was already submitted in previous Payment Applications period, then the same Data is automatically filled in the new Payment Application version and for any Next X version.
