## **New Functionalities:**

#### Structured survey (FEAD)

• SSF (404757) - There is a new standalone document type called Structured Survey for FEAD under the menu option 'Evaluation'. Users must have Managing Authority roles to read, create and send it.

## **Changes:**

#### Rural development programme (EAFRD)

• RDP (378486) – New fields were added for Context indicator value table (updated value).

#### Major project submission (Art. 102(2))

- MPS (404708) A new validation rule (2.69) was added to check if there is an answer for the field F.3.3. The paragraph for the Member State to commit on timely action will always be displayed, but "Member State name" will only be filled in automatically with the Member State description of the Major Project CCI Country code when answer is 'YES'.
  - 2.69 validate in F.3.3 that the question is answered (error)

#### Application (EGF)

- AP EGF (404026, 403411, 404028) A read-only section was added to report the total number of workers and the number of workers by sex, nationality and age group. This new section will only appear when targeted young persons not in education, employment or training (NEETs) present (Both for web and print).
- AP EGF (405477, 405478) There is now a new field, in case of redundancies before the reference period, asking for the date these redundancies took place and for an explanation (Both for web and print).

### Implementation Report (IGJ)

- IR IGJ (405948) Validation rule 2.9.15 is now only applied in the Annual Implementation Report 2018 and Final
- IR IGJ (400801) New validation rules 2.44 2.47 were added:
  - 2.44 validate in Table 2A per Priority Axis/Investment Priority/Category of Region when a Common Result Indicator has a Common Output Indicator used as target and a "Cumulative Value Total/Men/Women" > 0, that the "Cumulative Value Total/Men/Women" of that Output Indicator in Table 4A for the same Priority Axis/Investment Priority/Category of Region is > 0 (error)
  - 2.45 validate in Table 2A per Priority Axis/Investment Priority/Category of Region when a Common Result Indicator has a Common Output Indicator used as target and a "Cumulative Value Total/Men/Women", that this "Cumulative Value Total/Men/Women" is <= the "Cumulative Value Total/Men/Women" of that Output Indicator in Table 4A for the same Priority Axis/Investment Priority/Category of Region (error)
  - 2.46 validate in Table 2C per Priority Axis/Investment Priority/Category of Region when a Programme Specific Result Indicator has an Output Indicator used as target and a "Reporting Year Cumulative Value Total/Men/Women" > 0, that the "Cumulative Value Total/Men/Women" of that Output Indicator in Table 4A (Common) or in Table 4B (Programme Specific) for the same Priority Axis/Investment Priority/Category of Region is > 0 (error)
  - 2.47 validate in Table 2C per Priority Axis/Investment Priority/Category of Region when a Programme Specific Result Indicator has an Output Indicator used as target and a "Reporting Year Cumulative Value Total/Men/Women", that this "Reporting Year Cumulative Value Total/Men/Women" is <= the "Cumulative Value Total/Men/Women" of that Output Indicator in Table 4A (Common) or in Table 4B (Programme Specific) for the same Priority Axis/Investment Priority/Category of Region (error)
- IR IGJ (400797) The formulas for Tables 8 and 9 were changed in the Implementation Report.
  - For Table 8: Column 6 = (Column 5 / OP Table18a Union Support (A) for that Priority Axis and Fund) \* 100
  - For Table 9: Column 3 = (Column 2 / OP Table18a Union Support (A) for that Priority Axis) \* 100 and Column 5 = (Column 4 / OP Table18a Union Support (A) for that Priority Axis) \* 100

## Implementation Report (EGF)

 IR EGF (403605, 403612) - The layout of the table in Section 2.1 was changed splitting it into three separate ones: one for workers, one for targeted young persons not in education, employment or training (NEETs) and one for Beneficiaries (Workers+NEETs). When NEETs are not present, only the workers table will be displayed. (Both for web and print).

## Implementation Report (IGJ,ETC,EMFF,FEAD)

- IR IGJ ETC EMFF FEAD (346314) The validation rule 2.3 was blocking the validation of the Implementation Reports when a new Operational Programme version got adopted after the initial creation of the Implementation Report and referred to a Commission Decision with a date in the Reporting Year. Now, the validation rule 2.3 takes the creation date of the initial Implementation Report version (YYYY.0) into account
  - 2.3 validate that the linked Programme version is the last available with a Decision Date before or equal to the last day of the Reporting Year and with an "Adopted by EC" date < creation date of the initial AIR version. If this Programme version doesn't exist, it must have been linked to the first adopted version (error)'.
- IR IGJ ETC EMFF FEAD (346314) The document type "MS reply to observations in EC acceptance letter" was added but only when the Annual Implementation Report version is in status "Accepted by EC".

#### Annual Implementation Report (EAFRD)

- RDP AIR (380593) Structured financial instrument (section 10) is now implemented.
- RDP AIR (371296) New validation rules were implemented:
  - 2: Implementation report version has been validated. (Info)
  - 10: Validate that at least one official in charge of the Member State exists. (Error)
  - 30: Validate that the 'Monitoring committee approval date' is filled. (Warning)
  - 60: Validate that at least one Financial annex (system or other) is annexed to the AIR. (Error)
  - 70: Validate that a "Citizen's summary" is annexed to the AIR. (Warning)
  - 80: Validate that all integral documents have at least one attachment with a length > 0. (Error)
- RDP AIR (402504) The layout for indicators Overview tables (main and details) was improved in the snapshot report: section 1b (overview main) and annex II (overview details).

## **Defects fixed:**

#### Partnership agreement

• PA (404903) – Users were unable to validate Partnership agreement due to error with validation rule 2.6 'empty state' condition. This has now been fixed.

### Major project notification (Art.102(1) and 103) & Major project submission (Art. 102(2))

• MP MPN/ MP MPS (404964) - There was an error with section C.3 as the calculated field 3 was only taking 2 decimals from field 2. This has now been fixed.

#### **Commission Decision**

• COMDEC (382918) - The Link to Commission Decision dialogue was not being displayed fully in a few objects. This has now been fixed.

#### Implementation Report (IGJ)

- IR IGJ (407125, 407317) In the Implementation Report table 2c, there was an error while saving, if the fields about measurement ('Measurement unit for indicator' and 'Measurement unit for baseline and target') were left empty. This has now been fixed.
- IR IGJ (406976) In the Implementation Report table 2c, the achievement ratios were not calculated correctly. This has now been fixed.
- IR IGJ (400480) Table 1, Table 5 and ex-ante conditionalities tables (section 13) were not shown in the report. This has now been fixed.
- IR IGJ (405948) Validation rule 2.9.15 is now only applied in the Annual Implementation Report 2018 and Final.
- IR IGJ (408765) There was an issue with table 5 data for version 2015. This has now been fixed.

#### Implementation Report (FEAD)

• IR FEAD (404911) - There was an issue with Validation rule 2.15 (*validate for OP I in Table 2.3.2 on Output indicators on food support distributed that the annual values of Indicator IDs 12 or 13 > 0 when 11= 0*). This has now been corrected and the implementation requires both 12 and 13 to be >0 when 11 is different from 0.

### Implementation Report (ETC)

• IR ETC (408791) - There was an issue with table 3 data for version 2015. This has now been fixed.

## Annual Implementation Report (EAFRD)

- RDP AIR (403547) The sub-section about conclusion was missing. This has now been added.
- RDP AIR (405890) The import of Excel (.xls) file wasn't trigging the calculation of tables F (F1 and F2). This has now been fixed.
- RDP AIR (403257) Missing content in section 5 of main snapshot report was added. The layout was also improved.
- RDP AIR (403248) In section 7, the indicator code R2 AWU was appearing twice in quantitative values table and this was causing an error when editing. This has now been fixed.
