New functionality

Cooperation programme (ENI-CB)

- CP ENICB (11559,11330) – There is now a new object called ‘Cooperation programme (ENI-CB)’ under the menu option “Programming”. Click [here](#) to consult the quick guides available on the SFC2014 Portal.

Changes:

Partnership agreement

- PA (11621) - The desk officer can now decide that no Commission decision is needed for an amendment by performing the action "Accept MS decision" (AMD) on a Partnership Agreement version sent to the Commission. This will result in status "Adopted by MS".

Rural development programme (EAFRD)

- RDP (11448) – The chapter 7 of the Rural development programme was adapted after the Performance review. The table 7.1 was adjusted by removing the columns linked to milestones and a new calculation for the “Target absolute value (A-B)” was adapted accordingly. This applies only to the new versions and not for the previous version of Rural development programme.

National audit report (IGJ,ETC)

- NAR (11516) – The system now allows transitions between 'Analysed by EC (Conclusions transmitted)', 'Analysed by EC (Observations)' and 'Analysed by EC (No observations)'. This is useful in the scenario where the Commission sends an EC assessment letter with the status "Analysed by EC (observations)" or "Analysed by EC

(conclusions transmitted to AOD)" and the Member State reply with the document "Other MS document". The Commission will assess this reply and this could lead to another conclusion.

- NAR (11565) – The list of documents during the action "Mark as analysed with assurance package" now contains the EC assessment letters (CR.EAL) and EC Final Position Letter (CR.FPL) and Other Commission Document (CR.OC) type of documents.

Annual Implementation Report (EAFRD)

- RDP AIR (11544) – In the section 10, the system now prevents the user to remove the Date of signature of the funding agreement, if the Financial instrument(s) exist(s). The validation rule 155 has been created for it:
 - *EAFRD_AIR_AI_155 - "The Date of signature of the funding agreement can't be removed if financial instrument(s) has/have been added in field 5, please first delete the financial instrument(s)."*

Defects fixed:

Partnership agreement

- PA (11553) – When trying to add a Specific Target group in the "ESI Funds that will be used and main types of actions to be supported" in Section 3 > 3.1.5 Poverty/ Needs tab, the "Specific target group or geographical area and needs*" was not shown correctly as the text was overlapping. This has now been fixed.

Rural development programme (EIP)

- RDP EIP (11610) – There was an error when editing section 1.2 'Editor/Project coordinator'. This has now been fixed.
- RDP EIP (11611) – There user was getting an error when trying to send an EIP version to the European Commission. This has now been fixed.

National programme (AMIF,ISF)

- NP AMIF ISF (11562) – The User was unable to create a new programme version when it was in status "Not adopted by EC" because of an error "Object not found". This has now been fixed.

Designation of authorities (IGJ,ETC,EMFF,IPA-CB,FEAD,AMIF,ISF)

- DOA (11600) – The Send confirmation window was not displayed correctly in 1280x1024 resolution. This has now been fixed.

Major project submission (Art. 102(2))

- MPS (11566) – When a European Commission user refused a major project, the status of the submission would appear as "Adopted by EC" instead of "Refused by EC". This has now been fixed.

Major project notification (Art.102(1) and 103)

- MPN (11567) – When a European Commission user refused a major project (by choosing Start refusal -> Send refusal for adoption -> Refuse), the action could not be performed due to an error message. This has now been fixed.

Annual Implementation Report (EAFRD)

- RDP AIR (11544) – The Annual Implementation Report (EAFRD) couldn't be returned for correction due to an error. This has now been fixed.

Progress report

- PR (11603) – The Progress Report was failing after the migration to Java 8. This has now been fixed.

Financial data (IPA-CB)

- FD IPACB (11572) – The Compare function was not working on the Financial Data tab. This has now been fixed.

Excel

- XLS (11612) – The Columns Status and Decision were empty for all Excel documents generated with the "Export to excel" feature. The issue occurred for all objects in SFC2014. This has now been fixed.

Microsoft Edge

- ME (5159) – The Download link was not working on the Microsoft Edge web browser. This has now been fixed.
