Annual Implementation Report (EAFRD)

- RDP AIR (10856) - The Table of CAP impact indicators is now implemented in the section 7 from the Annual Implementation Report.

Defects fixed:

Partnership agreement

- PA (11733) - For the European Commission users, the "Commission Decision" text was missing on the "Link commission decision" window. This has now been fixed.

Operational programme (IGJ)

- OP IGJ (11731) - The amounts in Table18b were hard to read as the boxes were not sized correctly. This has now been fixed.

Rural development programme (EAFRD)

- RDP EAFRD (11648) - There user couldn't add measures in strategy section 5.2 anymore. This has now been fixed.

National programme (AMIF)

- NP AMIF (11637) - The User was unable to validate a programme because of an error. This has now been fixed.

National programme (ISF)

- NP ISF (11746) - The text in the Table 1 was incorrect. This has now been fixed.

Implementation Report (ALL)

- IR ALL (11712) - The version in the exported excel only contained the year but not the work version. This has now been fixed.

Implementation Report (IGJ)

- IR IGJ (11682) - The User was unable to validate a Implementation Report because of an unexpected error. This has now been fixed.

Annual Implementation Report (EAFRD)

- RDP AIR (11434) - The rule 270 had some precision issues when it was trying to compare the 2 values for the same indicator in the programme and the Annual Implementation Report. This has now been fixed.

Commission decision

- CD (11713) - In the exported Excels, the Decision tab was not being populated. This has now been fixed.

Quarterly declaration of expenditure (EAFRD)

- RDP DOE (11049) - When a measure was deleted in the Financial Plan of a Rural development programme, the Table of content item for this measure wasn't still available in the Quarterly declaration of expenditure of the same same financial year (YYYY-1Q4 - YYYYQ3). This has now been fixed.

Accounts (AMIF)

- ACC (11776) - The Validation rule 2.63 was not taking the correct accounts versions for calculation. This has now been fixed.

Annual control report (FEAD)

- ACR FEAD (11577) - The menu buttons « cancel », « validate » and « delete » were disappearing after uploading a document in the Annual control report. This has now been fixed.
