### **Changes:**

#### Operational programme (FEAD)

OP FEAD (12424, 12425,12426 12427, 12428) – Due to Covid-19 CRII changes, under the section 'Financing Plan', sub-section 'By year', there is now in the table an extra editable column. This extra column is a checkbox through which the Member State will request a co-financing rate of 100% to be applied to expenditure declared in payment applications during the accounting year 1 July 2020 - 30 June 2021 for the selected priority axis/axes.

### Cooperation programme (ETC)

• CP ETC (12464) – The validation rules 2.88 and 2.89 were using the date of 01.01.2020 in place of 01.02.2020. Now, in case of multiple last decisions <= 01.02.2020, the system links to the first occurrence and not the last.

### Rural development programme (EAFRD)

• RDP EAFRD (12434) – The item '2. Amendment modifying information provided in the PA' in the sub section "Amendment" of the General section is now disabled. It doesn't impact previous versions already sent to the European Commission or already adopted, it's only for ongoing or future programme versions.

#### **Annual Implementation Report (EAFRD)**

AIR EAFRD (12300) – There is now a new condition for the Warning 250. This warning is now relevant only if the
target indicator values for T8, T9, T10, T11, T12, T13, T22 and T24 are higher than in any previous year. This
modification applies to the current Annual Implementation Report year (2019) and the Annual Implementation
Reports greater than 2019, but it is not retroactively.

## Implementation report (IGJ/ETC/IPACBC/EMFF)

• IR IGJ/ETC/IPACBC/EMFF (12450) – The validation rule 2.87 should be error in AIR2018 and Final and warning in all others. Nevertheless, in the AIR2019, the validation was giving an error. Now it is correctly set into a warning.

• PAP IGJ/ETC/IPACB/EMFF (12446) – The list of Priorities were not displayed in the correct order for the table in the Expenditure section and the tables in the Appendix 1 and Appendix 2. This have been now fixed.
