## Changes:

### ***Operational programme (IGJ/ETC)***

- OP IGJ ETC (12546) - Tables 3, 4 & 5 (IGJ/ETC non-TA), Tables 10 & 11 (ETC TA) and Tables 12 & 13 (IGJ TA) – For Covid-19 measures, a number of Reserved Output and Result Indicators have been defined by the Commission. They can be used by the Member State by creating Programme Specific Indicators using the reserved codes of these Indicators.
  - When using a Programme Specific Indicator ID of a reserved COVID-19 Output/Result Indicator for ERDF/CF/ESF/YEI/ETC and the user clicks on Update an Alert is issued saying “You are using a COVID-19 reserved programme specific output/result indicator code. The title and measurement unit will be overwritten with their reserved values. If this was not your intention, press cancel.” When OK is pressed, the title and measurement unit will be overwritten with the official reserved values.
  - When using a Programme Specific Indicator ID of a reserved COVID-19 indicator that is not an Output / a Result one for ERDF/CF/ESF/YEI/ETC then an Alert is issued saying “You are using a reserved COVID-19 Indicator which cannot be used as result indicator for ERDF/CF/CF/ESF/YEI/ETC”.

### ***Operational programme (EMFF)***

- OP EMFF (12563) - There is now a new validation rule 2.43:
  - *validate in the Financial Plan by Union Priority (8.2), that the EMFF Performance Reserve amount for Union Priority 1 Measure 1b is null or 0 (error)*

## Defects fixed:

### ***Operational programme (IGJ)***

- OP IGJ (12593) – When using a Programme Specific Indicator ID of a reserved COVID-19 Indicator then on Update an Alert will be issued informing the user that they are using a Covid-19 reserved programme specific indicator code and that their title and measurement unit will be overwritten with the reserved values.

### ***Implementation report (IGJ/ETC/IPACBC/EMFF)***

- IR IGJ/ETC/IPACBC/EMFF (12562) – The Event Notification email was not being sent for workflow changes related to the Technical Return for IR. This has now been fixed.
- IR IGJ/ETC/IPACBC/EMFF (12566) – It was not possible to create a new version of Implementation report when the status was ‘Accepted by EC (Technical return)’. This has now been fixed.

## ***Annual Implementation Report (EAFRD)***

- AIR EAFRD (12582) – The validation rule 250 was raising an error for table T22 when the values were correct. This has now been fixed.

## ***Accounts (AMIF/ISF)***

- ACC AMIF ISF (12567) - The export to Excel on the Search screen was not correctly exporting the column Decision(s), when there are multiple decisions on a row. This has now been fixed.
