Changes:

Operational programme (IGJ)

- OP IGJ (12577, 12579, 12580, 12581, 12805, 12806, 12809) - The REACT-EU changes are now implemented in the Operational programmes (IGJ). The full changes can be consulted in the quick guide available [here](#). The changes are also reflected in the print version.

Cooperation programme (ETC)

- CP ETC (12840, 12841, 12842, 12844) - The REACT-EU changes are now implemented in the Cooperation programmes (ETC). The full changes can be consulted in the quick guide available [here](#). The changes are also reflected in the print version.

Operational programme (IGJ) & Cooperation programme (ETC)

- OP IGJ CP ETC (13096) - The length of the text box under section 1.2 was extended from 7000 to 10.000 characters.

Operational programme (FEAD)

- OP FEAD (12569) - The REACT-EU changes are now implemented in the Operational programmes (FEAD). The full changes can be consulted in the quick guide available [here](#) (FEAD I) and [here](#) (FEAD II). The changes are also reflected in the print version.

Rural development programme (EAFRD)

- RDP EAFRD (13075) - The presentation for article 59(6) in M04 and M12 has been improved. For M04, there is now first the EAFRD line and then EURI line, the amounts were aligned to the right and the currency (EUR) that

was missing is now displayed. For M12, besides the currency and alignment, the total is first displayed then EAFRD and EURI.

- RDP EAFRD (13068) - The specific output values are now displayed with only 2 decimals in chapter 11.5.

Cooperation programme (IPA-CB)

- CP IPACB (13105) – The OERDFCF common output indicators were added in the list of Table 4.

Designation of authorities (IGJ,ETC,EMFF,IPA-CB,FEAD,AMIF,ISF)

- DOA (12712) - The list of Character codes identifying the Type of Object, for the Designation of authorities, is now extended to allow new REACT-EU programmes (RE).

Implementation report (IGJ)

- IR IGJ (13066) - There are new validation rules for the implementation report: 2.176 and 2.177
 - 2.176 validate in working version 0 that a Citizens' summary (IR.CIT) is uploaded (error)
 - 2.177 validate in working versions > 0 that a Citizens' summary (IR.CIT) is uploaded (warning)

Payment application (IGJ,ETC)

- PAP IGJ ETC (12929, 12930, 12932) - The REACT-EU changes are now implemented in the Payment application (IGJ, ETC). The full changes can be consulted in the quick guide available [here](#). The changes are also reflected in the print version.

Quarterly declaration of expenditure (EAFRD)

- DOE (12755) - The EURI budget code impacts the declaration of expenditure as following:

The budget codes must have the structure 'BBBBBBBBB MM RRR PP'. Basically when the first 'R' digit will be 6, 7, 8 or 9, the budget item (BBBBBBBBB) displayed in SFC will be 08030103 instead of 08030102

- in Column "Applicable Article", description was fixed for EURI and the Measure reference starts By 'EURI;'
- In Summary table 'Expenditures and corrections' it is now displayed:
 - both the EURI (if exists) and Non-EURI lines by measure (and EURI lines, at the end of the table)
 - Total EAFRD (without EURI)
 - Total EURI
 - Total (EAFRD + EURI)
- For each measure tables
 - EURI lines (if exists) , at the end of the table
 - Total EAFRD (without EURI)
 - Total EURI
 - Total (EAFRD + EURI)

Accounts (EAFRD,EAGF)

- ACC EAFRD (13023) - The template for the Responsibilities section has changed for Accounts 2020 onwards, and the field 'State which Auditing Standards have been applied' is now under the General Basis of Opinion section.

Defects fixed:

Operational programme (IGJ)

- OP IGJ (12981) - The snapshot document was displayed twice in the document section. The first one was in the correct place, as expected, but the second one appeared in the field, which is reserved for European Commission submitted annexes. This has now been fixed.

Operational programme (FEAD)

- OP FEAD (13074) - In the Financing Plan Table, the order of Years were not correct and it was not possible to sort, when the Years extended up to 2022. This has now been fixed.

Rural development programme (EAFRD)

- RDP EAFRD (13065) - The EURI co-financing rate was not displayed in edit mode in section 10.3 if the co-financing rate was previously filled in. This has now been fixed.
- RDP EAFRD (13069) - In the PDF report, in chapter 11.5, when transition applies, the column Target value was referring to 2023 instead of 2025 like it should. Now it correctly displays 2025.
- RDP EAFRD (13070) - In the PDF report, the box for some of the rich text, (depending on the content filled) was very narrow. This has now been fixed.
- RDP EAFRD (13093) - In section 10.3, the user was able to encode the Financial instrument if the "type of region/other allocation" was not selected beforehand when this shouldn't be possible. Now the system correctly prevents it from happening.

Implementation report (AMIF,ISF)

- IR AMIF ISF (12952) - In the section S9 - Covid19 Expenditure, the Text Editor box was giving an error when the user tried to save the data. This has now been fixed.
- IR AMIF ISF (13081) - When validating the implementation report, the validation rule 2.9 was being triggered when not expected because it was taking into account also the deleted common indicators. This has now been fixed.
