## ***Annual Implementation Report (IGJ, ETC)***

IR IGJ (13387) / IR ETC (13391) – Changes for REACTEU added: Add REACT-EU to Fund code in all tables where Priority Axis is dedicated to REACT-EU.

## ***Accounts (EAFRD)***

RDP ACC (13338) - Improvements in SFC2014 for audit opinion and management declaration for FY2021.

RDP ACC (13425) - Version of WinCheckCSV 22.1.011 for Annual Account 2021 updated.

## ***Declaration of Expenditure (IPA-RD)***

DOE IPARD (13375) - The contribution rat (column R) taken into account for the IPARD declaration of expenditures should be the latest one available in the IPARD programme in force and if there is no rate in 2020 for the given measure , the system should take the rate of 2019 etc.

## **Defects fixed:**

### ***Operational Programme (IGJ)***

PRG IGJ (13457) - REACT-EU Table 20 contained wrong calculations of proportions. They should be calculated as follows:

- The Fund lines should be divided by the Fund's Total Union Support from table 18 without REACT-EU.
- The total line should be divided by the total Union Support for both Funds without REACT-EU.

### ***Accounts (IGJ)***

ACC IGJ (13430) - Appendixes 1-8 - There was an extra total (per category of region or reactEU) which should not be there for CF. This is fixed.

### ***Accounts (AMIF/ISF)***

ACC AMFISF (13414) - Restriction removed on audit year in section III.A.

ACC AMF ISF (13452) - The resettlement is not saved for 2021.
