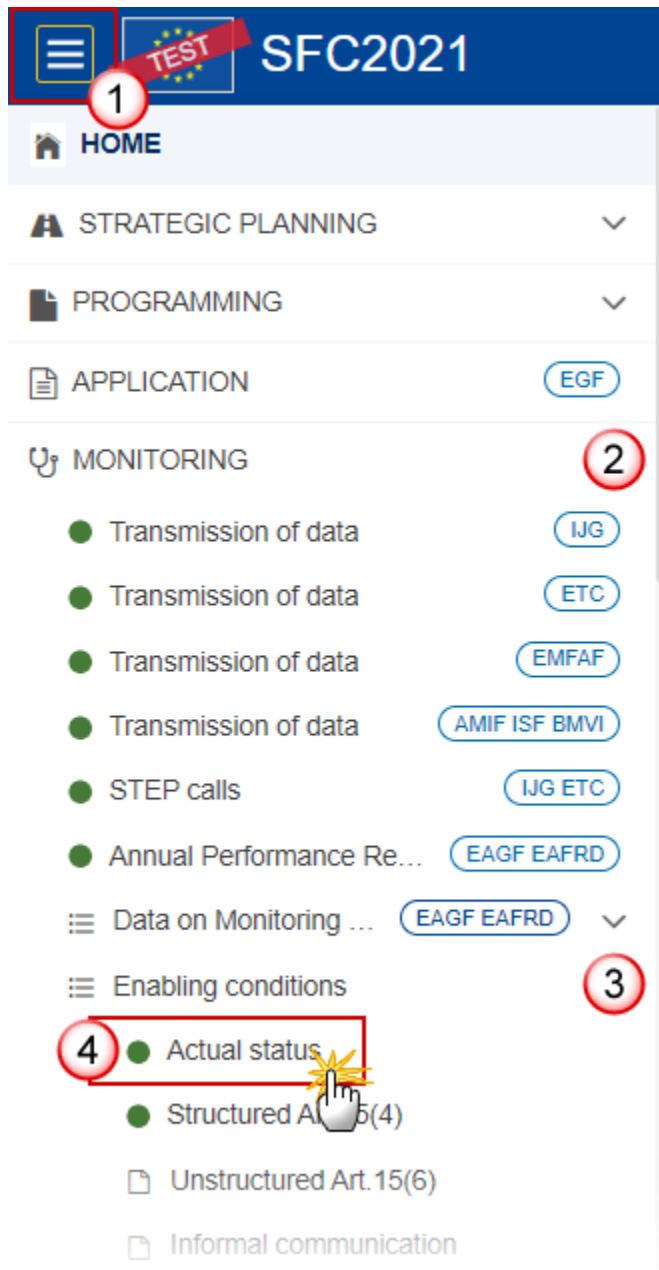

<p>REMARK</p>	<p>The User is an identified User and has the role of MS Authority or MS Managing Authority with Update rights (MSAu or MSMAu).</p> <p>The User can consult the actual status of one or more Enabling Conditions in the system. The actual status dashboard will show the actual status per Member State, CCI and Enabling Condition. Clicking on a row will show the procedures and Commission decisions that determine this actual status (First adopted programme version in which the Enabling Condition was used, assessed article 15(4) procedures in status ASSESSED BY EC (AGREED), and assessed article 15(6) procedures with a “Commission decision on non-fulfilment” document referring to a Commission decision).</p>
